2. Fees, Training Period and Fit to Work

2.a. Fees - Cross out non relevant underlined section -

Fundamentals Training: Owner agrees that the fee for fundamentals training is \$4,000. Of said fee, a deposit of \$1,000 will be due upon acceptance and to hold your training spot. The remaining balance is due in two payments, one of \$1,500 payable the day you bring your horse, and the final payment of \$1,500 due upon pickup of horse.

Targeted/Problem Solving/Tune up or other by the week training:

The fee for this horse will be \$ \_\_\_\_\_ per week and must be paid in advance.

In addition;

Owner agrees that they are responsible for furnishing all feed, supplements and supplies. In the event Trainer furnishes any feed, supplements and/or supplies, Owner agrees to reimburse Trainer for all such expenses. Owner also agrees to be responsible for farrier care.

2.b. Fundamentals training period is typically around eight weeks. Training spots are available by application only. Your training deposit (see 2.a.) and a filled out and signed copy of this agreement should be delivered to FAB Horsemanship, 2765 SW 3rd Avenue, Fruitland, Idaho, 83619. If the training spot is canceled by the owner without a sixty-day advance notice the deposit will be forfeit.

2.c. Horses that are lame and/or not reasonably physically able to handle and/or continue training work will need to return to their home for a minimum of two weeks or until they are able to go back into training work. In such cases it is possible that the horse may need to wait until the next horse in line is finished with their training cycle before they are able to return to FAB.

3. TRAINING REVIEW and PICKUP Owner agrees that upon and/or before pickup of horse at completion of fundamentals training the horse's future and/or regular handler and/or owner will spend a minimum of six hours with the Trainer and the horse reviewing and applying training the horse has received.

4. VACCINATIONS Owner certifies that to the best of their knowledge; the horse is free of all communicable diseases upon delivery to Trainer and is properly up to date on vaccinations.

5. EMERGENCY CARE Trainer agrees to employ reasonable attempts to contact Owner, in the event of horses' medical emergency. If Trainer is unable to contact Owner, and if emergency care appears warranted in the reasonable opinion of Trainer, Trainer shall secure emergency veterinary and/or farrier care deemed reasonably necessary for the health and wellbeing of the horse. Trainer assumes that the Owner does desire surgical care for the Horse, if recommended by a veterinarian in the case of life-threatening colic or other life-threatening condition, unless Trainer is expressly instructed in writing by Owner that surgical care is not desired for horse. Owner agrees that Trainer is authorized, as Owner's agent, to arrange direct billing to the Owner for emergency care.

6. INSURANCE Owner agrees that it is the Owner's sole responsibility to insure the horse if they so choose. Owner is aware that Foundations and Beyond Horsemanship does not carry any insurance on horse, that the horse is not covered by Trainer under any public liability, accidental injury, theft or equine mortality insurance. Therefore, Owner agrees that all risks connected with training (or for any other reason for which the horse is in the possession of the Trainer) are to be borne by Owner.

7. VIDEO RECORDING of FAB trainers, horses, or students is not allowed. My signature below signifies that I understand and agree to abide by this policy.

8. LIMITATION OF LIABILITY AND INDEMNIFICATION Owner, agrees to hold harmless and release Trainer and/or Trainer's associates, apprentices, agents, family members and employees from any and all loss, damage or legal liability arising from any fault or negligence of Trainer and/or Trainer's associates, apprentices, agents, family members and employees. Owner agrees to bring no claims, demands and/or litigation against Trainer and/or Trainer's associates, apprentices, agents, family members and employees. Owner also releases the property owner/s of any properties the horse may be on at any time during the training period. Trainer shall not be liable for any sickness, disease, theft, death or injury that may be suffered by the horse while in Trainer's custody, nor for any other damages or injury arising out of or connected with boarding, trailering and/or training or other services relevant to this Agreement. Trainer will not be liable for any personal injury or disability which the Owner, and their agents, representatives, family or guest may receive while on premises. Owner agrees to indemnify and hold Trainer harmless from any claim related to damages, illness, or injury to or caused by the horse. Owner acknowledges the inherent risks associated with equine activities, and is willing and able to accept full responsibility for his/her own safety and welfare and releases the Trainer and any other equine Owner or agent. Owner also acknowledges that Owner executes this agreement on behalf of Owner, as well as all of Owner's children, family members and guests. Trainer agrees to assume all risk to persons and property associated with boarding and/or training horse and to hold harmless Owner in the case of any damage and/or injury to any persons involved in training and/or care of horse as well as to any damage and/or injury to property and/or equipment.
