Emergency Medical Care: If, in our judgment, your dog requires immediate medical care and we are unable to reach you, we will take your dog to a veterinarian or animal hospital.

Yes _____ (Initials) By initialing here, I agree to be solely responsible for the payment of all medical bills for my dog and I release **Sunset Acres Dog Ranch** its officers, directors, agents, volunteers and employees from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.

_____ Sunset Acres Dog Ranch reserves the right to immediately change my dog's type of boarding if it is necessary to protect the health and well-being of my dog, other dogs, or Sunset Acres Dog Ranch staff.

_____ All dogs must be healthy and current on required vaccinations. I will be required to bring a copy of my dog's updated vaccination records from my veterinarian prior to or at time of boarding to ensure my dog's safety as well as that of other dogs boarded at Sunset Acres Dog Ranch.

_____ If my dog exhibits symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy or diarrhea, I will not bring my dog for boarding without a release from my veterinarian stating that my dog is not contagious. If my dog is found to have fleas or ticks, Sunset Acres Dog Ranch will treat my dog for an additional fee. If my dog comes into heat while at Sunset Acres Dog Ranch, I will need to have a pre-arranged individual who can come pick her up immediately.

_____ I understand and acknowledge that there are certain risks involved in boarding, including but not limited to dog fights, dog bites to humans or other dogs, and the transmission of diseases. Any medical expenses will be my responsibility and I release Sunset Acres Dog Ranch of any charges.

_____ All charges must be paid in full upon return of my dog. Sunset Acres Dog Ranch accepts cash, check or Zelle as payment. Sunset Acres Dog Ranch reserves the right, without notice, to adjust its fees for services. Dogs left ten days beyond the agreed return date will become property of Sunset Acres Dog Ranch and may be disposed of at the kennel's discretion.

_____ Changing a dog's food can cause upset stomach; owners are encouraged to bring their dog's food from home. Owners are welcome to bring their dog's own bedding and/or toys if desired, however Sunset Acres Dog Ranch cannot guarantee that they will be returned in the same condition. For my dog's safety, no choke chains, corrective collars or harnesses are allowed.

_____ I understand that staff is on property overnight in a separate building. However, there are periods of time when staff is offsite and dogs are left in their pens in the kennel building without immediate supervision. The building is equipped with a smoke detector that is monitored remotely.

b. _____ I release, indemnify, and agree to hold Sunset Acres Dog Ranch harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Sunset Acres Dog Ranch, except which may arise from the sole gross negligence or intentional and willful misconduct of Sunset Acres Dog Ranch, including, without limitation, (i) any inaccuracy in any statement made by myself or information provided by me to Sunset Acres Dog Ranch, (ii) my dog, including but not limited to destruction of property, dog bites, injury and transmission of disease, and (iii) any action by myself which is in breach of the terms and conditions of this agreement.
