I understand that the rules can update or change at any time throughout my reign and will abide by those rules and regulations at any time there is an update or change. I understand as a National Queen I must compete at the upcoming international pageant. I understand I must return to my National Pageant to pass my title on to the new queen. I understand that if I fail to fulfill my duties, I will be required to relinquish my title, turn in my crown and sash, and forfeit all awarded and forthcoming prizes.
