- I. Call to order President Tony Esson

 - A. Business Manager Sherice Villeme. She reported that she had a discussion with the lawyers about the Bylaws. They said these had to be completely reworked, which would be difficult to do, since it required a vote of 2/3 of the total membership to enact changes. It was stated though that we had the authority to clarify deeded restrictions as long as they did not restrict the membership.
 - B. Facilities Manager Tom Hall. Everything is shutdown and winterized. There is no new construction planned at this time. He said valves in the pool are going to need to be replaced. He will try to work on them to get them to continue working, but they will eventually have to be replaced at a cost of about \$400. The horse swings have been repainted by Melissa Warner and will be put up in the spring.
