Health and Medical Information:

Certain health and medical information about you is protected under the Health Insurance Portability and Accountability Act, HIPAA, and applicable state law. Security/ Confidentiality:

No transmission of data over the Internet or any wireless network can by guaranteed to be 100 percent secure. TPC will, however, use a number of physical security methods (such as locks and alarm systems); electronic security methods (passwords and encryption methods); and procedural methods (rules regarding the handling and use of information) to protect the security and integrity of information submitted through this website.

Information Collection and Storage:

Personally Identifiable Information: TPC does not collect information that personally identifies you unless you choose to provide it to TPC (for example, web pages that allow you to contact us). The personal information you submit is shared only with those people at TPC who need this information to respond to your question or request, and as otherwise permitted by law to allow TPC to operate our business or to comply with applicable laws.

As used in this Privacy Notice Policy, personal information does not include information protected under HIPAA or applicable state laws, which is protected as described in the section "Health and Medical Information" above.

Non-Personally Identifiable Information: TPC collects information that does not personally identify you for various purposes (for example, website usage, traffic patterns, site performance and related statistics based on your visits to our website).

TPC collects some of this information using persistent "cookies" to recognize a repeat visitor and gather general information about how the site is viewed. TPC also collects and logs the IP address of each visitor to gather aggregate data on visitors to our site. Keep in mind that neither cookies nor IP addresses are used to collect any personal information from you.

Email:
