Give us the ability to adapt to the cultural, economic and social changes that occur in the neighborhoods we serve.


Receive our prayer, O God.





Annual Congregational Meeting

January 22, 2023 11:30 am Bethany Hall

President Kim Larson opened the January 22, 2023 meeting and announced there was a quorum.

- 2. Bob Dickerson made a motion to adopt the 2023 annual meeting agenda. Brian Henrickson seconded the motion. The annual 2023 annual meeting agenda was adopted.
- 3. Brian Henrickson made a motion to adopt the January 23, 2022, annual meeting minutes. Bob Dickerson seconded the motion. Motion passed.
- 4. Shawn Swenson presented the 2022 treasurer's report from the finance board. Brian Henrickson made a motion to approve the treasurer's report. Bob Dickerson seconded. Motion passed.

The budget comes in at a \$16,331 deficit but the Finance Board feels that budget is achievable. Brian Henrickson made a motion to accept the 2023 Operating Budget. Chad Willis seconded. Motion passed.

- 8. New Business -
 - a. Resolution # 1 First Fruits Benevolence Giving 2023, page 43. Wayne Nelson made a motion to approve Resolution # 1. Brian Henrickson seconded. Motion passed.
 - **b.** Resolution # 2 Updating of Calvary Lutheran Church's Constitution, page 44. Paper ballots were passed out, 94 to 4, resolution passed.
 - c. Resolution # 3 Updating of Calvary Lutheran Church's Bylaws, page 44. Paper ballots were passed out, 94 to 2, resolution passed.

9. Election of Council Members- Names read - Shawn Swenson, Mary Jo de Cathelineau, Amber Willis, Caleb Hanson, Brian Henrickson, Corey Nelson, and Bridget Peterson. Kim Larson asked for any other nominations. None named. Bob Dickerson made a motion to approve the Election of Council Members, Gayle Larson seconded. Motion approved.

- 10. Motion to amend agenda was made by Tom Gilbertson to suspend the Robert Rules and to amend the agenda to add the use of the Jerry Anderson funds to upgrade the church's technology infrastructure. Kelly Welch seconded. Motion passed.
- 11. Discussion was held in regard to the use of the Jerry Anderson funds. Shawn Swenson detailed his discussions with professionals that advised Jerry Anderson in gifting the funds to Calvary, such as Duane Amundson and Bradley Schmidt, Attorney at Law.
- 12. Discussion was held on the need for an upgrade in Calvary's technology infrastructure to enhance our in-person and digital worship services. Mike Schroeder gave a detailed assessment of what is needed to update and improve the technology system.

Chad Willis made the following motion:

WHEREAS, The December 21, 2022 balance of the Jerry Anderson Original Capital Account is \$207,832.72 AND a need has been identified for the upgrade of our technology infrastructure to enhance our in-person and digital worship experiences, BE IT RESOLVED, that Calvary Lutheran Church approves an expenditure of the Jerry Anderson Original Capital Funds, not to exceed \$100,000, to be used as matching funds raised by the congregation, to professionally upgrade the technology of our video, audio, and electrical infrastructure related to the production, display, and transmission of worship services.

More discussion followed:

Dion Warne made a friendly amendment to the original motion:

WHEREAS, The December 21, 2022 balance of the Jerry Anderson Original Capital Account is \$207,832.72 AND a need has been identified for the upgrade of our technology infrastructure to enhance our in-person and digital worship experiences, BE IT RESOLVED, that Calvary Lutheran Church approves an expenditure of the Jerry Anderson Original Capital Funds, not to exceed \$100,000, to be used as a **50-50 match** raised by the congregation, to professionally upgrade the technology of our video, audio, and electrical infrastructure related to the production, display, and transmission of worship services.

Chad Willis accepted the friendly amendment to the motion. Bob Dickerson seconded the motion. Motion passed unanimously.

President Kim Larson made a comment to remember Jerry Anderson and to be thankful for his gift to Calvary Lutheran Church.

Thankful and Grateful

As I write my final Annual Report for Calvary Lutheran Congregation, I continue to reflect on the passage from Philippians 1: 3-6. "Every time I think of you, I give thanks to God. Whenever I pray, I make my requests for all of you with joy, for you have been my partners in spreading the Good News about Christ from the time you first heard it until now"! Yes, the last 50 years has been a wonderful and sometimes challenging vocation, but has been most rewarding and I am grateful to each and every one of you for your support and prayers.

During 2023, I have had the privilege to officiate at 25 memorial services, baptize 14 children and teenagers, officiate at 4 weddings at Calvary and Green Lake Chapel, assist 12-10th graders as they Affirmed their Baptism in the Rite of Confirmation and warmly greeted and welcomed 17 new members into membership at Calvary. The Grief Care class of 25 plus members each week was truly a learning experience as we learned some ways in grieving the loss of loved ones together. Our affiliation with Svea Lutheran Congregation has been a wonderful partnership in providing pastor coverage and support to them.

So it is with a note of sadness, thankfulness and gratitude that I write this last Annual Report for Calvary Lutheran. PRESIDENT'S MESSAGE TO THE CONGREGATION SHAWN SWENSON - PRESIDENT OF THE CONGREGATION

There are different ways of serving, but the same Lord is served. There are different abilities to perform service, but the same God gives ability to all for their particular service. The Spirit's presence is shown in some way in each person for the good of all. 1 Corinthians 12:5-7

Wow, 2023 was quite the year at Calvary. Starting with the adoption of a new Constitution and Bylaws and a big initiative to upgrade the Video and Audio technology and ending with the retirement of Pastor Dean Johnson and the hiring of Pastor Dwaine Sutherland.

When I began as President in February, I wanted to prioritize several important tasks that I thought were important to Calvary in 2023 and beyond, and to keep those in mind as we went through the year. Those items were:

- A/V Upgrades Funded and Installed
- Development of Depreciation schedule and Capital Savings Plan
- Dean Johnson Career and Retirement Celebration
- Review and Update the Personnel Manual
- Revise or create a new strategic plan

As with most of my ambitious checklists, I was unable to complete them all in the time allotted. I knew from my previous 5 years on the council that things move slowly, and it takes sustained effort to accomplish tasks in the church context. Still, I am happy to have taken this approach and the ability to begin or accomplish the work on most of the items. The credit really goes to our staff and members for these accomplishments.

Members and contributors provided \$150k towards the new project for A/V upgrades thanks to an approved matching donation from the Jerry Anderson funds. Mike Schroeder and the committee have put valuable time and effort into moving this forward. A lot of work went into the bid process including research and professional consulting. The committee has narrowed the search to our preferred vendor and is ordering an acoustical analysis. We hope to be under contract with the vendor in coming weeks so items can be ordered, and installation can be scheduled as soon as possible. Much thanks to Mike Schroeder, Dean Johnson, the AV committee and the stewardship committee for their efforts in this project.

The depreciation schedule/capital investment plan came about as we have dealt with increased repair and maintenance costs on our aging facility. There are multiple benefits to putting together a proper capital assessment including strategic planning and proper stewardship of our capital reserves. I have prepared an initial list of capital items and I intend to continue pressing the issue forward on the Finance committee.

Pastor Dean's career and retirement celebrations were a big success. I especially want to thank the committee members who worked for multiple months to coordinate the 50-year celebration and the following retirement events. They were engaged and also flexible given the circumstances around our staffing capabilities. Thank you to Duaine Amundson, Karen Rinke, Joan Hanson, and Kelly Welch.

The Calvary Personnel Manual was reviewed and replaced in 2023 with the new and improved Calvary Employee Handbook. The old handbook had been out of date for several years, and multiple law changes in 2023 made it a necessary time to do this work. Thanks to Personnel Committee, Finance Committee, and Council for taking time to review and approve. Thanks to Vinna Human Resources for their local expertise in crafting the new handbook.

Although one of my major goals in 2023 was to (again) attempt to move forward the strategic planning process around the May timeframe, this proved to be difficult. That timing and availability of an outside consultant was difficult amidst other concerns at the time. I think it remains one of the primary goals of the church as we continue to navigate change and look to the future.

As far as difficulties, the year extended some additional changes to the staff. Pastor David's departure and an unsuccessful search for an interim pastor throughout much of the year highlighted the scarcity of available candidates and the difficulty of finding the right pastor for that job. The change to the council size and committee structures also presented an unexpected shift in the governance of the church. Going to a smaller council size relieved many of the prior members from their committee assignments and some of our primary committees have become defunct or underrepresented. It remains extremely vital that we strengthen the committees and reporting process for the sake of broader representation, transparency, and to support the staff with decision making.

In summary, it was a year of immense change. Multiple layers of change occurring within a span of 12-15 months. We have had loss and suffer grief. We have had blessings and feel joy. We have had doubts and suffer uncertainty. It is understandable that this much change has caused some difficulty for our organization and members. We have called a new Lead Pastor for the first time in many years and the Call Committee deserves a huge thank you for their work and ongoing work. We have also retired our longest serving Pastor who has been a cornerstone of our church and companion in Christ for decades.

Let us look to the past for wisdom and to the future for opportunity. Let us focus on the "why" and not the "who, what, where". We have much more to give and much more to do to fulfill Christ's vision for us in the coming years.

For this reason I remind you to keep alive the gift that God gave you when I laid my hands on you. For the Spirit that God has given us does not make us timid; instead, his Spirit fills us with power, love, and self-control.

FAMILY PROMISE 2023 ANNUAL REPORT

Family Promise works with families to take the necessary steps toward lasting independence. At Family Promise of Kandiyohi County, the mission is to help homeless **families**. We unite the faith communities of the area to help families find new homes and maintain their dignity. Calvary is one of 12 LOCAL churches active in this program. Family Promise provides support to families with shelter, food and case management services as they navigate life's toughest challenges.

Family Promise of Kandiyohi County has relocated to a new space in 2023. Calvary members pitched in to clean, supply and improve some of the apartment spaces in an available space on the northwest side of downtown Willmar. New families moved in in July, and more and more space is being approved for occupation. At full capacity, we could be housing many more occupants than when in the churches. Plus, the families will have much more dignity.

We are so thankful for the CWELCA donation of \$500.00. This donation will see its best use to pay for mattresses at the new facility.

The needs are constant as dollars pay shelter rent and provide staff and office supplies. Please consider a contribution to the QR code if you are able, or if you wish, leave a donation in another way - just drop off at the church office.

Most importantly, please consider volunteering to provide a simple meal to share with the homeless families. They are so appreciative of this help and friendship act.

FINANCE COMMITTEE 2023 ANNUAL REPORT

We are very thankful for the continued support of our members in 2023. Financially speaking, Calvary had a positive year. The general fund performed well due to decreased expenses and relatively stable income. Total assets increased by over \$400k, and dollars borrowed from the special funds in 2022 were repaid and no new borrowing was required. The congregation and supporters of Calvary also came through in fundraising efforts for the Audio-Video project and to support our youth in camping and other activities.

General Fund income decreased by 1.3% over the prior year and expenses decreased 15.5%. The decrease in expense is largely due to reduced staffing costs due to the departure of pastoral staff in 2022 and 2023. The finance committee continues to budget for a 2.5 pastor staffing model and maintaining the current overall expense structure. Our partnership with Svea provided financial support to our pastors as well as the general fund, which was mutually beneficial for both churches.

Capital Fund experienced a net increase of \$206k as of 12/31/23 which is the appreciation of the Jerry Anderson investment with Thrivent (5.5% increase, net of fees). Thrivent continues to provide quarterly meetings to update the finance committee on current economic outlooks and implications of our investment strategy.

Special Funds saw a net increase of nearly \$115k over 2023, with a year-end total of \$580,831. This includes the \$75k raised for the AV upgrades and \$25k in investment income/appreciation from our Edward Jones account.

The Endowment fund had investment income/appreciation of \$41k during 2023 and paid out \$14k. Balance as of 12/31/23 was \$652k.

We are also in the process of receiving a very generous gift from the estate of Carol Jean Carlson who passed away in September 2023. This will be placed in Special Funds as a memorial for her and her parents, not to be used to support general operations. Blessed be her memory.

Overall, the general fund remains the primary concern going forward. The budget process was very thorough again this year for 2024 and we plan to continue this level of effort going forward. A large majority of our assets are restricted in some manner, and are not able to be used for operations, so the Finance Committee is carefully monitoring general fund performance and utilizing special funds when possible, to cover eligible expenses, repairs, and replacements.

Priorities for 2024:

- Development of a capital expense plan to track deferred maintenance and replacement needs of our many property-related equipment and furnishings. To be used for future capital projects and strategic planning.
- Review all Special Funds accounts and make an updated tracking log related to the source, restrictions, and original balances. Awareness and use of special funds, memorials, and scholarships is important for both the church and the donors.
- Recruit additional interested members to join the committee.

HOLY COMMUNION TO THE HOMEBOUND

The sacrament of Holy Communion is made available to any homebound Calvary member unable to attend church services. The sacrament is delivered to these individuals the third Sunday of the month. We currently have ten servers, three substitutes and approximately forty recipients. This number includes a few non-members requested by family members and the pastors of Calvary Lutheran. The homebound recipient is notified each month prior to the Communion Sunday to verify the server's visit. At present we have homebound communicants in nursing homes, care facilities and in private homes in the Willmar area. The communicants deeply appreciate this added connection to their church.

Please call the church office if you would be willing to serve as a Holy Communion server or if you would like to be included as a homebound recipient.

2023 was a year of very generous giving by our church members to help God's people in need.

March is our Food Shelf Month for collecting food and monetary amounts for the Kandiyohi Area Food Shelf. This year the amount of food we collected was 354# and the amount of money donated was \$3744.00. The Food Shelf Basket is in the Narthex throughout the year for food collection.

May is Mental Health Month. Messages were written in the Bulletins and Messenger to give information on healthy mental health and where to seek help. Our committee fund donated \$500.00 to the Willmar High School to supply needs for grieving friends of a classmate who died.

In July and August we participated with United Way in collecting school supplies for our area schools.

The purpose of the Stewardship Committee is to develop practices that spiritually and effectively enhance the church functions of serving and supporting. In conjunction with the pastors, the Committee is responsible for the congregation's development of the spiritual principles of time, talents and financial stewardship.

As part of our Fall Stewardship Campaign, two temple talks were presented to the congregation where we encouraged members to examine their ability to give whether it is financial giving or giving of their time and talents.
