Mandate on singing/music during liturgies effective Nov. 20, 2020 (until further notice)

The use of cantors is prohibited with the exception of liturgies on Christmas Eve and Christmas Day.

No singing of Mass parts

No Facility Rentals

All Sacraments

Recorded music is not allowed during liturgies.

NO congregational singing

Instrumental music is allowed during liturgies.
