Fr. Feller's Corner

Difficulties can become opportunities and even victories. I am told, at the height of priestly vocations, the communities of Our Lady of the Plains were served by 6 pastors. Now, there is just one pastor. His mission remains the same: to care for the salvation of all the souls in this area, and manage the temporal, or material, goods (finances, properties, etc.) that support this mission. Thankfully, he walks with a good deacon, generous retired priests, and faith-filled communities of lay men and women.

The challenge of declining number of priests can be an opportunity. This past March 2024, in a letter addressed to parishioners, Fr. Lynn wrote that one of the purposes of pastoral planning "is to reinvent how we manage and serve our parishes and faithful by becoming more efficient in how we conduct business to provide more time for our priests to evangelize and minister." Thus, we created the director of operations position to oversee and direct the administrative functions of the parish including finances, human resources, and the management of physical properties. The director will collaborate with our buildings and grounds committees, finance council, and parish groups.

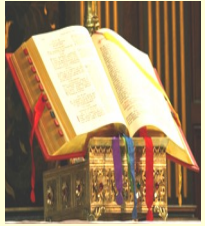

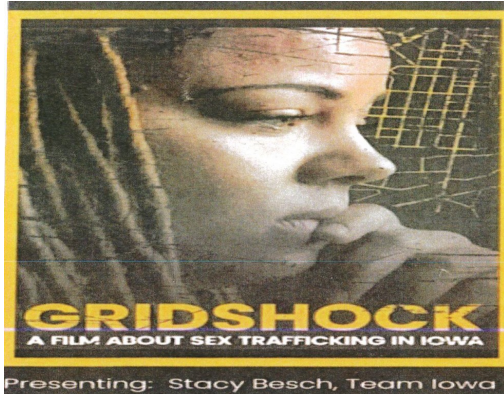


