Ordinance # 2410-F

AN ORDINANCE REGULATING PARKING

BE IT ORDAINED by the President and Board of Trustees of the Village of Ogden, Illinois, that Ordinance # 8-3-2000 be amended to provide as follows:

Section 1: No person shall park any semi-trailer or semi-trailer tractor on a street in any area zoned “residential” or any other location posted “No Parking” for a period longer than is necessary for reasonably expeditious loading or unloading of such vehicle. No such semi-trailer or semi-trailer tractor shall be parked overnight in an area zoned “residential” unless the vehicle is parked on private property only.

Section 2: No vehicle of any type shall be parked or driven on any public street or alley unless the area on which it is parked or driven has been surfaced with rock, gravel, oil and chip or concrete. This shall not prohibit temporary driving and parking for the purpose of loading and unloading vehicles in an expeditious manner provided the driving and parking on said unimproved area does not damage the surface of the street. Parking of any vehicle on or over any sidewalk is prohibited except for the expeditious loading or unloading of passengers or cargo.

Section 3: Parking vehicles of any kind in the alleys of Block 7 of the Original Town of Ogden is prohibited except for a reasonable period of time necessary while actually loading or unloading the vehicle. Block 7 in the original town of Ogden is bordered by East Ave., Broadway, Leney and East Main.

Section 4: Parking is prohibited along the north side of Broadway Street from the west line of Leney Street to the east line of Lot 7 (bordering the east side of the alley) of Block 7 of the Original Town of Ogden between the hours of 9:00 a.m. and 5:00 p.m. on Mondays through Fridays except for commercial vehicles while temporarily parked as necessary for and while actually loading and unloading vehicles.

Section 5: Persons in violation of this Ordinance shall be ticketed and fined a Class “C” fine for each violation. The vehicle can be towed to the nearest impoundment at the owner’s expense and shall be reclaimed only upon payment of the fine and towing plus any storage fees for said vehicle.

This Ordinance shall be published in pamphlet form and shall be in full force and effect after its passage, approval and publication as provided by law.
