SOLICITOR ORDINANCE No. 2410-D

Be it ordained by the President and Board of Trustees of the Village of Ogden **that Solicitor Ordinance #55-3 be amended to provide as follows:**

SECTION 1. Permit Required. It shall be unlawful for any person, firm or corporation to engage in the business of soliciting, selling or promoting of any merchandise, article or information without having first obtained a permit and ID from the Ogden Village. Churches, schools, and other non-profit charitable organizations are exempt from a fee payable to Ogden Village. These organizations must register with the Ogden Village and obtain a permit and ID to be worn when engaging in conversations with the citizens of the Village.

SECTION 2. Applications Applications for such permits shall be made to the Village Office and state therein the number of vehicles if any, intended to be operated and also name of owner(s), driver license number(s), address(s) and the license plate number of the vehicle(s). Name, address, and organization of each solicitor shall also be furnished. Solicitor shall also register the article, merchandise or information to be solicited, sold or promoted.

SECTION 3. Fee The fee for such permit shall be \$50.00 for each vehicle for an annual permit and \$10.00 for each daily permit. If not using a vehicle the fee shall be \$50.00 for an annual permit and \$10.00 for a daily permit. If a group is involved the daily fee will be \$5.00 per person.

SECTION 4 FRAUD Any licensed solicitor who shall be guilty of any fraud, cheating or misrepresentation whether through himself or an employee while acting as a solicitor in the municipality or who shall barter, sell, trade, or promote any goods, wares, merchandise, other than those specified in the application for a permit shall be fined according to a Class "A" fine. The president or mayor may revoke the permit of an offender.

SECTION 5 Penalty Any person, firm or corporation violating any provision of this ordinance shall be fined according to a Class "A" fine for each offense. A separate offense shall be deemed committed on each day during or on which a violation occurs or continues.

When religious or not for profit person or groups fail to register with the village a fine of Class "C" will be issued.

Any for profit person or organization who fail to register with the village will be subject to a class "B" fine.
