STW HOA

As it is now, the HOA Board has voted to continue to limit access to the clubhouse and other park amenities to residents only until at least the next board meeting. As a result of this, our annual yard sale in November will not happen this year. This decision is predicated on concerns over the virus.

Please know that opening the park amenities will be priority one on the agenda for a decision by the board going forward as new recommendations are received from our attorneys and the government.

Members of the board and I really appreciate your cooperation and support during this emergency. Please continue to keep in mind that all amenities will remain limited to resident access. Social distancing and masks are desired. So far, I am happy to report, we have not had any cases of the virus in the park.

On to other activities which will continue regardless of the Corona Pandemic. Some of these are as follows:

 Once again, we are coming up on the time of the year when all shareholders are eligible to run for the three HOA Board vacancies which are coming open the first of the year. These director positions will be voted on during the annual meeting by shareholders. This is your chance to be heard and to make a difference. If there are concerns you may have with the way things are being managed by the board you can work through it with the other board members. If you are interested in being considered, you must:

- Be a shareholder.
- Provide notice of your intent to Cindy Porter (Secretary) or Carla in the office on or before December 19, 2020.
- Provide an updated resume to Cindy or Carla for distribution to shareholders on or before December 24, 2020.
- Restrooms in the clubhouse have been painted. The office building restrooms will be painted next.
- Our HOA Board has voted to change our current relationship with Lifestyle Realty. Effective October 26 2020, there will no longer be an STW Realty. Going forward Lifestyle Realty will rent sales space in the office and will conduct park sales from there. This action will simplify our relationship with Lifestyle Realty and will get STW out of the real estate business. Lifestyle Realty has access to the

Multiple Listing Service (MLS), and will be listing all properties on there as well as their website. You will see their signage going up soon.

- Window replacement for the front window in the clubhouse has been delayed until the vendor can build an appropriately sized window. They brought a replacement, but it did not fill the bill.
- Over the past several weeks our STW Board has been actively working with Bank OZK to offer you updated options we believe will simplify submission of your monthly fee payments to the park. It is our understanding that this will not only simplify the payment process for residents but will also reduce handling costs to the park. To facilitate this process, Bank OZK will be sending a letter along with coupon books to all our residents. Detailed instructions will follow shortly.
- Bill Gorman, Community our Association Manager, and Jack Pugh, Manager, our Grounds traveled through the park in August to identify residences which need some TLC. Letters and calls have gone out to owners identifying the concern. Several folks have already taken action to correct the concern. While this is normal for this time of year with many of our folks up north, we will be following up with those who have not yet responded in an effort to keep our park looking great.
- We will be sending out updated, stateapproved rules and regulations to both

- share and non-shareholders within the next month.
- Finally, we on the board are concerned that there has been no access to shareholders for recent board meetings. During the pandemic we have been learning to use ZOOM to personal contact at meetings. At the October 22nd meeting we made the meeting available to shareholders via ZOOM meeting. few shareholders took advantage of this. We will use this experience to help iron out bumps going forward.

NOTES FROM THE OFFICE

Shareholders — The annual meeting and elections will be on Thursday, January 28, 2021. This means that First Notices will be sent out before the Thanksgiving Holiday. I know that many of our snowbird residents are unsure of whether they will be coming down this year. I anticipate sending out packets on or before Wednesday, November 25, 2020.

If you are a snowbird and are coming down <u>before Thanksgiving</u>, please let me know so I can send your packet to the correct address.

Non-Shareholders – 90-day notices were mailed out in September notifying all non-shareholders that governmental and utility charges in the amount of \$379.26 are due by January 1, 2021. Lot rent will increase effective January 1, 2021.

Payments – We are working with Bank OZK to offer our residents more payment options. Starting with your January 2021 monthly maintenance fee and

cable/internet payment, you will have three payment method options:

- Automatic Payments (ACH). Quite a few of you have been requesting this payment method. Now you will be able to set-up automatic monthly reoccurring payments directly from your bank account to STW's bank account, as some of you do for your utility bills.
- 2. **Online Bill Pay**. Many of you already send us a check directly from your bank. You will be able to continue doing this, but will need to change the address where you send the payment. Make sure you have your lot number on the check.
- 3. **Pay by Check**. You can continue to write-out checks, but you will need to include the monthly coupon slip for each month you are paying.

Bank OZK will mail residents information letters along with coupon booklets prior to January 1, 2021. We will also have a Bank OZK representative coming in to assist residents in signing up for Automatic Payments (ACH) in December.

Additional information, including an exact day and time for in-person sign-up assistance will be coming to you soon.

Statements: Are sent out around the 10th of each month to accounts with a balance due. If you feel there is an error, please contact the office so we can clear it up. We try to email as many statements and invoices as possible to save on postage.

<u>Trash</u>: Trash is picked up on Monday and Thursday starting at <u>9:00 a.m</u>. Please do not put your trash out the night before as we have a problem with critters getting into it and making a mess. If you put cardboard boxes into the dumpsters, please cut the tape holding them together, and fold them down to take up less space.
