CONDITIONS OF ENTRY

- 1. All entries must be insured by third party risks, and road vehicles must be fully licensed and tested in accordance with the regulation of that vehicle for road use. **Boiler certificates: Valid certificate must be available for inspection.**
- 2. Owners must ensure all drivers are fully competent and qualified in law to handle the class of vehicle exhibited.
- No exhibit or support vehicle may be left running unattended. Unattended vehicles must be left securely braked and or chocked.
- 4. A maximum speed of **5 MPH** shall apply to **ALL** vehicles on the rally site at **ALL** times.
- 5. Entries must be presented in a safe working condition.
- 6. Exhibitors must pay full regard to any instruction issued by any member of organising team and conduct themselves in a manner that will not inconvenience or endanger any other persons at any time.
- 7. All support vehicles must be left in your camping space.
- 8. For Health & Safety reasons you must arrive onsite before 10am (Fri, Sat & Sun), after this time the Exhibitors gate will be closed, and entry limited. If you arrive later than dusk, you will be placed in a 'Holding Area' overnight.
- 9. All engines must be in steam (or fires lit) by a reasonable time each day of event (non-steam in place).
- 10. Whistles, horns etc. will not be sounded unless in an emergency after dark.
- 11. There is to be no movement of engines or vehicles after dark without prior permission of the Section Organiser.

 This includes all movement to and from Beer Tent.
- 12. Advance Parking, **if available**, will be strictly at your own risk and by **prior arrangement only**. Some Protocol and additional photographic identification will be needed as South Cerney is adjacent to an active Military base.
