**11th Annual Smithmoor Invitational  
22 BPCR Winter Season Finale--April 11th, 2026**

Range Location	East Smithmoor Range, 291 County Rd 152, Carpenter, WY 82054
Rules	Current 22 BPCR Association rules will govern.
Eligibility	Invitational only
Entry Limits	Entries are limited to 30 competitors.
Firing Schedule	Firing will commence promptly at 8:30 am on Saturday. This is a one-day match, 40 record shots, with an additional 10 shot side match.
Course of Fire	10 record shots for each animal: chickens at 50 yards, pigs at 100 yards, turkeys at 150 yards, and rams at 200 yards. 8 minutes will be allowed for unlimited sighters and 10 record shots with a 15 second ready. A fifth station will also be added.
Fees	\$80.00 per competitor includes lunch. 100% is returned to the shooters through prizes, lunch, and range improvements.
Lunch	Will be provided.
Squadding	Squads will be assigned either by competitor's entry form & requests or randomly on the day of the match.
Rifles Allowed	All Rifles and equipment will conform to current 22 BPCRA rules.
Classification	The 22 BPCRA classification systems will be used in all matches. Individuals who have not been classified will fire as "Unclassified" which will determine their future class.
Jury	A Jury of three competitors will be selected to settle rule disputes.
Awards	An Overall Match Championship Award will be presented for overall winner regardless of class. Awards will be given for 1st place in each class- Grand Master, Master, AAA, AA and A. Scope and iron sights will be grouped together.

Entries	Entry is made by sending the registration form and money, <b>due by March 15th</b> . Late entry fee will be \$10.00 extra. Entries will close when 30 applications are received. Folks that regularly shoot our monthly matches will be given precedence in receiving a spot in the match. If needed, a waiting list will be started. Sorry, but no refunds for cancellations will be given 30 days prior to event.
