# Bylaw Change Recommendations 2023-2024 SERC

#### Article III - Members

**Section 2.** The membership of the Southeastern Regional Council of ESA International shall consist of representatives of the states of Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, South Carolina, Tennessee, and Virginia.

### **Change to Read:**

The membership of the Southeastern Regional Council of ESA International shall consist of representatives of the states of Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, Tennessee, and Virginia.

Reason: Omit Maryland since they no longer have a state council

#### ARTICLE III – Members

#### Section 3. Now Reads:

Annual dues of \$15 per state shall be due and payable into the SERC treasury on the first day of January.

#### **Change to Read:**

Annual dues in the amount stated in the Southeastern Regional Council of Epsilon Sigma Alpha International Standing Rules shall be paid by each State to the SERC treasury by the first of January.

#### Reason:

We need to remove the numerical amount of the dues from the Bylaws and move them into the Standing Rules so that we can more easily make dues adjustment changes.

### <mark>Article VIII – Meetings</mark>

### Section 2. Now States:

The annual Conference site shall be selected on a rotational basis, and the Southeastern Region shall be divided into three (3) sections. The states comprising each section shall be:

Arkansas, Louisiana, Mississippi, and Tennessee Kentucky, Maryland, North Carolina, and Virginia Alabama, Florida, Georgia, and South Carolina

The manner of rotation shall be in the sequence named above. The SERC president shall be the designated party to sign the official contact for hosting a SERC conference. The Conference may be sponsored by a Region, state or multiples of states, with hostesses sharing one-half the profit with SERC.

### **Change to Read:**

The annual Conference site shall be selected on a rotational basis, and the Southeastern Region shall be divided into three (3) sections. The states comprising each section shall be:

Arkansas, Tennessee, Mississippi, & Louisiana Kentucky, North Carolina, South Carolina & Virginia Alabama, Florida & Georgia

The manner of rotation shall be in the sequence named above. In the event, no state within the designated section bids, then any state within the SERC Region shall have the opportunity to bid for the annual conference.

The SERC president shall be the designated party to sign the official contact for hosting a SERC conference. The Conference may be sponsored by a Region, state or multiples of states, with hostesses sharing one-half the profit with SERC.

#### **Reason:**

First, Maryland does not have a state council, so they should be eliminated from the group. The above grouping is in a closer proximity to each other than the previous grouping, and makes it easier for multiple states to host convention.

### Section 3. Now States:

The annual Conference site for two (2) years in advance shall be selected by ballot vote during a called SERC meeting at the International Council Convention. In the event of only one (1) Conference bid, voting may be by general consent. The Hostess City and/or the State, sending a copy of the Conference bid to the 2<sup>nd</sup> Vice President by April 15, shall determine date, place and a pre- approved registration fee for the annual Conference. The registration rate for the Conference shall be submitted to the Executive Board by March 15 for approval. A copy of the Conference budget shall be submitted with the formal bid. Should there be a need to raise/lower the registration fee, after the State was selected for the Conference at the SERC Meeting at the International Council convention, a letter stating the amount and reason shall be submitted to the Hotel Contracts Chairman, for recommendations, additions and deletions by February 15, prior to the Formal Bid being submitted to the Second Vice President.

### **Change to Read:**

The site of the SERC Conference shall be determined by a ballot vote of the membership at the annual SERC conference three years hence from bids submitted.

The Hostess city and/or state shall send a courtesy bid to the 2<sup>nd</sup> Vice-President by April 15<sup>th</sup>. Two years or more from the SERC Conference, the bidding city and/or state shall submit the proposed conference rate to the SERC Executive Board by March 15 for approval. A copy of the Conference budget shall be submitted with the formal bid.

The hotel contract shall be submitted to the Hotel Contracts Committee for recommendations, additions and deletions. The SERC president shall be the designated party to sign the official contact for hosting a SERC conference.

Should there be a need to raise/lower the registration fee, after the State was selected for the Conference at the SERC Conference a letter stating the amount and reason shall be submitted to the Executive Board for approval.

### **Reason:**

Due to difficulty getting hotels, it is necessary to obtain information 3 years in advance. Due to cost changes, it's best to wait 2 years out to submit the registration rate and budget. We do not hold business meetings at IC Convention, unless a Special Call meeting is announced, plus more of the SERC membership will be at the SERC Conference than the IC Convention.

### <mark>Article VIII – Meetings</mark>

### Section 4: Now Reads:

Special meetings may be held at the call of the President or by the Executive Board.

### **Change to Read:**

### Section 4: Insert the following and renumber existing Sections 4-5 as 5-6

The Second Vice President shall provide site ballots, if needed, for distribution by the Credentials Committee. Selection shall be determined by a plurality vote cast by delegates. In the event only one bid is received, voting shall be by General Consent.

### **ARTICLE XII - Appointed Officers and Standing Committees**

### Section 1. Now Reads

There shall be the following appointed officers: Finance Chair, Scrapbook Chair, SERCH Editor, Chaplain, Auditor, Awards Chair, ESA for St. Jude Chairs - Senior and Junior, Easterseals Chair, Hotel Contracts Chair and the Association of the Arts Chair.

### **Change to read:**

There shall be the following appointed officers: Finance Chair, SERCH Editor, Chaplain, Auditor, Awards Chair, ESA for St. Jude Chairs - Senior and Junior, Easterseals Chair, Hotel Contracts Chair and the Association of the Arts Chair.

### **Reason:**

Remove Scrapbook Chair. Since the SERC Executive Board is trying to watch the budget and has the fiduciary responsibility to cut cost that are not needed. Scrapbooks are a perk, and not necessarily needed.

### **ARTICLE XII - Appointed Officers and Standing Committees**

### Section 1. b

Now Reads:

b) The Scrapbook Chair shall prepare a scrapbook of the year's activities, using material furnished by the SERC President and Southeastern State Presidents, pertaining to activities of their State Council, and present the scrapbook to the SERC President at the annual Conference.

### Delete Section 1b and renumber existing c – k as b-j

# Standing Rules - Southeastern Regional Council of Epsilon Sigma Alpha International

### Rule 10. Now Reads:

All checks written by the SERC Treasurer shall be co-signed by the SERC President. Furthermore, a copy of the monthly bank statements shall be forwarded to the President immediately upon receipt. (Nov 1999)

### **Change to read:**

All checks written by the SERC Treasurer require email approval from the SERC President. The email approval shall be saved to a flash drive and shall be given to the next treasurer for accounting purposes. The email approvals shall be kept for a minimum of 7 (seven) years. Furthermore, a copy of the monthly bank statements shall be forwarded to the President immediately upon receipt.

### **Reason:**

Acquiring dual signatures for officers in different states is extremely hard. It has taken months to get the officers on a signature card slowing the process of reimbursements to our members. Email approval gives us a documented trail on transactions.

### Rule 12. Now Reads:

Each chapter in the SERC States is requested to make a minimum annual donation of \$10.00 paid to the SERC Treasurer (July 2022).

Change to Read:

Each chapter in the SERC States is requested to make a minimum annual donation of \$15.00 paid to the SERC Treasurer.

### **Reason:**

Our annual budget is dependent on donations from our SERC Chapters. This requested donation amount has not been increased in many years and would help to bring our annual budget into alignment with our current expenses.

### Add Rule 18:

The annual dues of \$30 per State shall be due and payable into the SERC treasury on the first day of January.

### **Reason:**

We need to remove the numerical amount of the dues from the Bylaws and move them

into the Standing rules so that we can more easily make dues adjustment changes.

We have not increased our state dues in many years. We need to make this increase to help bring our annual budget into alignment with current expenses.
