Terms and Conditions

Frontline Kent 1940 is a family show with the minimum of rules and restrictions. However, co-operation with our simple safety and legal requirements is essential.

5 MPH SPEED LIMIT

A speed limit of 5 mph. is applied within the showground. No unauthorised moving of vehicles during events. Drivers are to obey instructions from officials. No transference of fuels to be carried out. Under Section 1, 2 and 3 (as amended) of the Road Traffic Act of 1991 you could be prosecuted for driving recklessly at this type of event.

VEHICLE MOVEMENT

Vehicles are not permitted to leave the site between the hours of 9am and 5pm on show days except in an emergency.

GENERATORS

Generators must conform to the current Health and Safety regulations and the Electricity at Work Act. This includes ground spikes (earthing). Any cost incurred ensuring that your generator complies with current legislation will be at your own expense.

WEAPONS

Only vehicle-mounted deactivated weapons or those that are part of a static display will be allowed on site. These must remain secure at all times and must comply with current HM Government regulations. No weapons are to be carried around on the site without prior authorisation from the organisers. **NO BLANK ROUNDS or PYROTECHNICS** may be brought on site unless pre-arranged with the organiser. Organisers insist that **ALL WEAPONS** brought onto the site for display comply with **CURRENT UK** legislation. Owners must bring their firearms certificates to the event. Anyone found to be disregarding this request will not be re-invited. Knives are not allowed unless in a display, must be encased and only drawn in a display arena. **No BB guns or air rifles to be used on site except in any designated organised ranges.**

ANTI-SEMITISM

The display of anti-Semitic literature and artifacts is strictly forbidden. If any of this material is found you will be asked to leave the showground and will not be welcome back.

SS insignia forbidden except by prior approval in connection with a relevant and historically accurate display.

GENERATORS

Generators must conform to the current Health and Safety regulations and the Electricity at Work Act. This includes ground spikes (earthing). Any cost incurred ensuring that your generator complies with current legislation will be at your own expense.

NOISE

Unnecessary noise is restricted from 11pm until 8am the next morning; this includes sirens, gunfire, pyrotechnics and music. Please note that given the nature of this event, there may be occasional loud bangs as part of the displays. Warning will be given where possible.

OPEN FIRES AND BBQs

Open fires and BBQs on the ground are strictly forbidden. Any damage to the ground created by campers/traders will be repaired at their own costs.

CAMPING

No public camping unless agreed with organisers and tickets are purchased.

FOOD CONCESSIONS

The only food and drink allowed to be sold will be as agreed in advance. All food hygiene and Gas/PAT certificates must be up to date and copies sent to the organisers with booking forms. No alcohol is to be sold on site other than from licensed bars.

LIABILITY

Neither The Hill 112 Memorial Foundation nor Betteshanger Parks, while having security on site, accept any responsibility for persons, vehicles, military or otherwise, or equipment on site. No liability is accepted if the show is cancelled for any reason.

TRADERS

Traders must not sell items that are either illegal or that the organisers deem inappropriate for a family event. Alcohol may be included in raffle or tombola prizes but must be handed to a responsible adult, never to anyone under 18 years of age. All traders must have £5 million public liability or third-party risk insurance. Documentation is to be available for inspection at any time by the show organisers or health and safety officers. Stallholders must be equipped with a fire extinguisher on their pitch at all times. All on site sleeping accommodation **MUST** be fitted with a working smoke detector.

Vehicles are not permitted to leave the site between the hours of 9am and 5pm on show days.

Vehicle owners must ensure visitors do not touch or climb on their vehicle without the owner's express permission. They must display a sign making that restriction clear and must not leave their vehicle unattended at any time. Failure to follow this procedure will mean any liability for damage or injury resting with the vehicle owner.

SALE OF WEAPONS

The certificate should be attached to the weapon or ready for inspection by the police. Replica guns or guns manufactured solely as blank firing devices can be sold or displayed.

Live firing, blank ammunition or pyrotechnics are not allowed to be displayed, sold or brought into the showground. The display and sale of inert explosive devices is only allowed if the vendor or owner can demonstrate that the item has been previously dismantled to prove that it is free from explosives. The item must have a label attached to declare that it is free from explosive material. The show organisers do not accept any responsibility or liability for the inspection of the device.
