Please include names for extra passes on a separate sheet. Entry may be denied after this time for health and safety reasons. All traders must be in position by 8am Saturday and vacate the site by Monday at midday. Arrival can be on Friday afternoon/evening or Saturday morning. **Traders must provide the tables and chairs they need to service their own stalls. Pitch size must allow enough space for any vehicles staying on the pitch. Alternatively, they must be removed to a parking area.**
