Terms and Conditions

Family Military festival & Country Fair. We WILL meet again is a family show with the minimum of rules and regulations, However, cooperation with our simple safety and legal requirements is essential

5 MPH SPEED LIMIT

A speed limit of 5mph is applied throughout the site from booking in onwards. Drivers who disobey the instructions will be asked not to return the following year. No transference of fuels is to be carried out. Under Section 1, 2 and 3 (as amended) of the Road Traffic Act of 1991 you could be prosecuted for driving recklessly at this type of event.

VEHICLE MOVEMENT

No unauthorised moving of vehicles during the event times of 9am – 5pm on Show Days is to happen. Hazards lights are to always be on when the engine is running. Drivers who disobey the instructions will be asked not to return the following year. If you must move on site during show times you MUST be escorted by an official wearing the appropriate Hi Vis clothing.

GENERATORS

Generators must conform the current Health and Safety regulations and the Electricity at Work Act. This includes ground spikes (earthing). Any cost incurred to make sure you meet the requirements is at your own cost.

WEAPONS

Only vehicle-mounted deactivated weapons or those that are part of a static display will be allowed onsite. These must always remain secure and must comply with current HM Government regulations. No weapons are to be carried around on site without prior authorisation from the show organisers. NO BLANK ROUNDS or PYROTECHINCS may be bought on site unless pre – arranged with the show organisers. Show organisers insist that ALL WEAPONS bought on site for display purposes comply with the CURRENT UK legislation. Owners must bring their firearms certificates to the event. Anyone found to be disregarding the above WILL NOT be welcomed back. Knives are not allowed unless in a secure display. If part of a uniform they MUST BE encased and only drawn in a display arena authorised by the show organisers. NO BB guns or air rifles are to be used on site except in an designated official range.

The sale of weapons will be allowed with pre-authorisation by show organisers. Certificates should be attached to the weapon ready for inspection by the Police or firearms department. Replica guns or guns manufactured solely as blank firing devices can be sold or displayed with prior agreement. The display of Inert explosive devices is only allowed if the vendor or owner can demonstrate that the item has been previously dismantled to prove that is free from explosives. The item must have a label attached declaring it is free from explosive material. The show organisers do not accept any responsibility or accountability for the inspection of devises.

ANTI – SEMITISM

The display of antisemitic literature and artefacts is strictly forbidden. If any of this material is found, you will be escorted of the show ground and not allowed back. SS insignia is also forbidden except for prior approval in conjunction with a relevant and historically accurate display.

NOISE

Unnecessary noise is restricted from 11pm until 8am the following morning; this includes sirens, gunfire, pyrotechnics and music. If you generator is needed for medical equipment please advise at time of booking in so we can allocate your camping pitch accordingly.

OPEN FIRES AND BBQ'S

ALL open fires and BBQ's are strictly forbidden on this show ground. If it is noticed that someone has an open fire or BBQ it will be extinguished and you will be asked to leave and not be welcome back.

FOOD CONCESSIONS

The only food and drink allowed to be sold will be agreed in advance. All Food Hygiene and Gas/PAT certificates must be up to date and available to be shown when required. A copy must be sent with you booking in form as required. NO alcohol is to be sold on site other than from the pre agreed licensed bar and traders.

LIABILITY

Neither Hill 112, The show or Betteshanger Park accept responsibility/liability for persons, vehicles or other items while on site. As a show, security will be provided, but again no liability or responsibility will be taken by either the show nor Betteshanger Park.

TRADERS

Traders must not sell items that are either illegal or items that the show organisers deem inappropriate for a family event. Alcohol may be included in raffle or Tombola prizes but MUST be handed to an adult, never to anyone under the age of 18. Please use the Think 21 policy. All traders MUST have a £5 million public liability or third-party risk insurance. Documentation is to be available for inspection at any time when requested to be seen by a show organiser or Health and Safety officer. Stallholders must be always equipped with a fire extinguisher on their pitch. All on site sleeping accommodation must have a working fire alarm fitted.

FIRE EXTINGUISHERS AND SMOKE DETECTORS

Due to the new Health and Safety guidelines, we must insist that all traders have a suitable working fire extinguishers, and for all other guests working smoke detectors should be used in accommodation if you stay overnight (camping, caravans, campervans). Booking in will check this on arrival. Stalls will also be checked for fire extinguishers during the show.
