

Village of Iola Regular Meeting Minutes~Monday August 10<sup>th</sup>, 2020 @ 6:00 p.m.

The monthly Village Board Meeting of the Village of Iola was held Monday August 10th, 2020 at 6:00 p.m. via GoToMeeting & in person, by special accommodations. President Joel Edler called the regular monthly meeting of the Iola Village Board of Trustees to order.
