Discussion was held regarding the Sewer Main Relocation Agreement. The Agreement is for Parcel 26 35 71247. Glenn and the property owner went over the agreement. Glenn made a motion to recommend a resolution from the agreement to be presented to the Board of Trustees at the December 12, 2023 meeting and have it signed by the property owner prior to the December 12th meeting.

Glenn presented a breakdown of Future Sewer & Water Expenses, (breakdown attached). Glenn stated we should be setting money aside for future expenses, \$15 per quarter per unit for Relining Rehab Fund. Septic Hauler Income should be placed in a Replacement Fund. Action on these suggestions will be made at a later committee meeting.

Our last review of Water Rates was in 1997. A total of .17 cent increase over 18 years. Chairperson McCoy would like a semiannual review of Water Rates.

Jim made a motion for a \$2 per Unit increase to Sewer Rates effective January 1, 2024, Pamela Seconded. Motion passed.

No other business was presented. Glenn made a motion to adjourn, Jim Seconded.
