Be it resolved by the Iola Village Board of Trustees, that effective immediately the Village of Iola will accept the following addition to Ordinance No. 2019-1 ALL-TERRAIN/UTILITY TERRAIN VEHICLES TRAILS AND ROUTES VILLAGE OF IOLA, WAUPACA COUNTY, WISCONSIN:

Section 1 — Intent

The Village of Iola, Waupaca County, Wisconsin hereby adopts the following all-terrain vehicle (ATV) and utility terrain vehicle (UTV) upon roadways listed in Section 3. Following due consideration of recreational value to connect trail opportunities and weighed against possible dangers, public health, liability aspects, terrain involved, traffic density and automobile traffic volume, this route(s) has been created. (start of addition to ordinance) Any operator or passenger shall comply with all federal, state, and local laws, orders, regulations, restrictions, and rules. All ATV/UTV rules of operation outlined in Wis. Stats. § 23.33 and Wis. Admin. Code ch. NR 64 are adopted and incorporated. (end of addition)

Motion seconded by A. Bauer. Roll call vote. 7-yes, 0-no, and 0-abstatin. Motion adopted. Motion made by R. Meyers to adopt Resolution 2024-6 an update Ordinance No. 2019-1 ATV/UTV to not allow open intoxicating beverage or modifications to exhaust system/muffler on ATV/UTV. Seconded by P. Parks. M. McCoy stated that allowing this would create an island in Iola where ATV/UTV operators could not drive into town with their open intoxicating beverages. J. Rassmussen stated that he would like the two topics broken apart into two separate resolutions. R. Meyers rescinded his motion and P. Parks rescinded her second. Motion died.

M. McCoy made a motion to table Resolution 2024-6 an update Ordinance No. 2019-1 ATV/UTV to not allow open intoxicating beverage or modifications to exhaust system/muffler on ATV/UTV. J. Rasmussen seconded the motion. 6-yes 1-No (Schustek).

§186-8 F. Overnight camping prohibited.

- (1) No person shall use any automobile, trailer, camper, mobile home or tent within the village limits for overnight sleeping or accommodation for no more than 7 days unless authorized by the Village of Iola or property owner. This excludes designated camping sites.
- (2) No person shall use any street, park bench, parking lot or public lands for overnight sleeping accommodation unless authorized by the Village of Iola or property owner.
- (3) No person shall prepare food or meals in any automobile, trailer or vehicle while it is on public grounds or streets within the village unless authorized by the Village of Iola or property owner.
- (4) No person shall rent to any person any parking lot, tent or land knowing that it will be used in violation of this section unless authorized by the Village of Iola.
