As we transition into the fall and winter months, please take a moment to review the winter ordinances outlined in this newsletter. These regulations are important for ensuring safety and accessibility throughout the season.

No Parking on Residential Streets

NO residential parking on Village of Iola Streets from 12:00 am (midnight) to 7:00 am from November 1st through April 1st. To facilitate street clean-up from a winter weather event(snow and/or ice), residential parking is prohibited on all Village streets from 12:00 AM (midnight) the day prior to the start of a winter weather event through 24 hours following conclusion of the winter weather event.

**Tree Trimming** 

Be sure that branches are at least 10 feet above sidewalks and 14 feet above streets.

#### 🕾 Snow and Ice Removal 🔆

In the event of snow and ice accumulating on sidewalk, the owner, occupant, or person in charge of any parcel or lot, is responsible for clearing said sidewalk within a day and a half of the completion of the winter event. Sidewalks are to be kept clear of snow and ice to a minimum of four feet in width. If ice has formed on any sidewalk in such a manner that it cannot be removed, the owner, or person in charge of the parcel or lot shall keep the sidewalk sprinkled with sand and/or salt to permit safe travel by pedestrians. Please reference ordinance 233-10 for details.



#### RECYCLING CENTER HOURS **OCTOBER-MARCH:**

Thursday's 2:00 p.m. to 4:00 p.m. and Saturday's 9:00 a.m. to 12:00 p.m. Recyclables are free to drop off at the Recycling Center. Recyclables need to be sorted. For trash garbage tags are available at the Recycling Center, Iola Sentry Foods, or the Village of Iola Clerk's Office. The cost is 5 tags for \$20.00.These trash bags can be dropped at the recycling center during normal recycling hours.
