Remember that Live Scan is a CA requirement this year. You must have an ORI# in order to submit your volunteers for clearance. If you have questions about your application status or how to complete it, please email the DOJ at: authorizationguestions@doj.ca.gov

ASAP submission is not yet available in the Data Center, but you can still get it ready to go. Make sure both you (President) and your Safety Officer have access to the Data Center now. Don't wait until the last minute. Your Safety Plans must include your updated Board of Directors and the dates for your coach and safety training sessions in order to be approved.

As we begin year of Little League, know that training in rules is already scheduled for all divisions of baseball and softball.
