

## **PRIVACY POLICY**

Protecting our private information is our priority. The S.O.U.L Clinic website is a resource, information, data collection and fundraising site. By using the S.O.U.L Clinic website you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to provide you with products and services offered on our Site, S.O.U.L Clinic may collect personally identifiable information, such as your:

- SSL Protocol
