Please bring exact change when paying property taxes in cash.

When paying by mail, send your check or money order and the bottom portion of your tax bill. If you would like a receipt, please include a <u>self-addressed stamped envelope and both portions of your bill</u> and the top half will be returned to you. If your check is not filled out correctly it will be returned to you. Please include a phone number on your check so we may contact you if there is an issue. This can help avoid late fees.

We now have a locked drop box outside our door for your convenience. Please do not leave cash.

Please pay with a separate check if you are also paying summer taxes.

You will still receive your bill if your taxes are in escrow and your mortgage company will request your information.

Any check returned to us due to non-sufficient funds will result in a \$10.00 fee due to bank charges. Payment is then to be made by money order, cashier's check or cash.

After 5 pm on February 14, 2024 taxes are considered late and penalties will be added.

As of March 1, 2024, all taxes are turned over to the county and are then payable to the Shiawassee County Treasurer in Corunna. Call 989-743-2224 for the amount.

Early Voting 2024

We have worked together to collaborate with Shiawassee County and have signed an agreement for the location of our 9-Day Early Voting site.

Antrim Township Residents that would like to vote early and in person in all Federal and State elections in 2024 can vote at 1042 N. Shiawassee St., Corunna, MI 48817. Absentee ballots will still be handled at the local clerk office and in person voting on the day of the election will be held at the Antrim Township Hall.
