A public water supply (PWS) that fails to monitor for Synthetic Organic Chemicals (Soc) - Regulated must perform public notice according to Tier 3 requirements as soon as practical, but no later than 12 months after the public water system learns of the violation or situation. Repeat notification must be performed every 12 months in which the violation persists. Public notification for a monitoring violation mandates both the content of written materials, as well as the timely delivery of those materials to all persons served by the PWS.
