He stated that the survey is almost complete and still looking into grant money for the project. He will give a more complete report when the survey is finished.

Jim Kramer asked the council about closing off some of the streets around the Baptist church next June for the Church's 150th Anniversary celebration reunion. The City Council told Jim just to inform city hall of the dates so that they could block off the streets. Also Jim asked about an update on the street/blacktop situation. Dave said that the company had not gotten back with him yet.
