

Differences between Psychic and Medium

When considering the differences between the psychic and the medium, it may not be as clear cut as you might think.

PSYCHIC

Psychics are able to ascertain information about a person, such as their personality, likes and dislikes, as well as information relating to their past, that the person would generally have not told anyone. A possible reason for this being that the psychic is able to gain an insight about a person from that person's energy, the aura as it is more commonly called. As an example, the process of psychometry, whereby energy from a person permeates into an inanimate object, such as a necklace, ring, or watch, that the person has worn on a regular basis. The aura is constantly radiating away from the person, as such anything coming into regular contact with the aura will become saturated by that energy and a residue of the persons energy then permeated into the item. The psychic is able to then hold an item such as mentioned above, and access the stored energy, which is perceived by the psychic as visual and emotional stimuli.

Generally speaking, the psychic works with a physical person in order to garner information about them. When taking this a step further however, such as with a tarot reading, the psychic would be able to attain information appertaining to your past, present and future. In such a case, the psychic would likely refer to themselves as a clairvoyant. Clearly there is something else taking place here, other than the psychic merely "tuning" into your energy.

As a psychic develops, events happening in their own life as well as the experiences they undergo when working with people, would undoubtedly heighten their psychic awareness. It could be construed therefore that an external influence, a guide would be working with them in order to convey information, particularly those of probable future outcomes, however the psychic may not be aware of these very subtle differences, instead seeing the information as appertaining to the cards they are using, or indeed an object they are holding.

Various readings that are considered in the remit of the psychic are, psychometry, photograph readings, flower, or ribbon readings.

MEDIUM

Like the psychic, the medium is able to glean information about a person, though some of the specifics of a person may not be as pin pointed as that of a good psychic, though the medium needs to have a high degree of psychic ability.

The most notable difference between the two however is that the medium is able to communicate with spirits such as our loved ones and friends that have passed away.

Mediums are able to tell you about a person in spirit, and give evidence to you in very much the same way as a psychic would be able to tell you about you. As such, they would be able to provide evidence on a loved one's personality, likes and dislikes, the obvious difference between psychic and medium is that the psychic gleans information from a physical person, whilst the medium gleans information for a dis-incarnate person.

In essence, the medium is able to do all the things that a psychic is able to do, though an obvious statement would be that a person who is working totally within their psychic abilities would provide a clearer and more precise information about you. The medium works both as a psychic and a medium at the same time, and importantly would be very much aware of the spirit side of life and their influence with them in being able to convey information of a personal nature. The psychic would not be able to work with a deceased relative as they would not be aware of their presence.
