I certify that I have completed the audit of the Annual Return for the year ended 31 March 2024 of **Hanmer Community Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Other matters and recommendations

I draw the Council's attention to the following matters and recommendations which do not affect my audit opinion but should be addressed by the Council:

The Council has restated their total fixed assets figure

The Council have restated their 2022-23 financial year figure for total fixed assets from £400 to £300. We recommend that the Council make a disclosure when restating its figures and make clear on the annual return which figures have been restated.

Standing orders

Council's standing orders are not in accordance with One Voice Wales' model standing orders. We recommend that the Council ensure that their standing orders are complete by reference to the One Voice Wales' model standing orders.

There are no further matters I wish to draw to the Council's attention.
