1. APOLOGIES

Apologies were received and accepted from Cllrs P Pinnington, J Jones, Dr Redman

2. MINUTES

The minutes of the previous meeting of 19th November 2024 having been previously circulated were confirmed as a correct record and were signed by Chairman J Smith.

4. MATTERS ARISING

Ward Councillor Update

Ward Councillor J Newton was unable to attend but updated the Community Council by email that a highways team were dealing with pot holes one day per week to try and clear the backlog; Vehicle Activated Signs (VAS) will be installed at Cumbers Bank before the end of March, the VAS signs requested for the A525 have been included in the budget and are awaiting approval from Cardiff; the GoSafe camera van has been requested at Hanmer.

At the A525/Horseman's Green junction flooding area, WCBC are to install a pipe underneath the road to drain the flood water into the ditch.

The Community Council again wished to record their thanks to Ward Councillor J Newton for his diligence in getting this work done in the community and his quick response to any communication he receives.

Police Matters

PCSO Lisa-Marie Davies previously circulated the crime figures - there were no concerns raised. Chairman J Smith has telephoned the PCSO to request a meeting to discuss speeding issues and is awaiting a response.

Highway Matters

Data from the Speed Sign in Hanmer was distributed prior to the meeting, it was noted that the majority of vehicles pass at between 25mph and 30mph, with the school run times being the busiest, overall there is no improvement to the statistics.

The condition of the roads in Horsemans Green was discussed, with flooding and pot holes being of the greatest concern. The Clerk is to contact Hafren Dyfrdwy for an update on the flooding issues around the area.

Hanmer War Memorial Update

Specialist quotes are being sought due to the Grade II* listing and this is ongoing Hanmer Surgery

A new and pared down Business Plan has been submitted today with a meeting scheduled for the end of January for any updates. Chairman J Smith thanked Cllr B Weeks for her persistence in getting this far.
