Date: March 18, 2024

- To: All Churches in the Midwest Annual Conference
- Subject: Living Legends Application

Attached is the application for the 2024 Living Legends. Please ensure that each of your nominees are made aware of this honor and are provided with an application.

- 1. Persons seeking Midwest Conference Lay Organization Legend status must be nominated by the Local Lay Organization of their church; except that the Conference Lay Organization Executive Board may for special reason submit a nominee for consideration.
- 2. Each nominee should have at least eight (8) years of good, regular, and continuous service in the Local Church, the Local Lay Organization and/or former or current Conference Lay Organization.
- 3. Each nomination submitted shall be certified by the signature of the nominee's Local Lay President.

- 4. It shall be the responsibility of the Local Lay Organization to pay the **\$150.00 one-time** Living Legend Membership fee at the time of application. Checks, money order or cashier's check should be made payable to Midwest Conference Lay Organization. The application, fee, bio and picture should be mailed to the Midwest Conference Lay Organization, P.O. Box 300531, Kansas City, MO 64130 and received **on or before May 4, 2024, or (postmarked by May 4, 2024).**
- 5. All applications must be submitted to the Midwest Conference Lay Organization. The Midwest Conference Lay Living Legend Committee Membership Committee shall review all nominations for adherence to eligibility requirements and completeness of the application, including the necessary certifying signature. The nominee's Local Lay President will be notified of the Committee's determination. If the nominee is found to be ineligible, the fee submitted shall be promptly returned to the nominee's Local Lay President.
- 6. The application packet should include: the application, fee, bio and picture.

The deadline for receiving applications is May 4, 2024 (postmarked).
