WHAT IS THE GOVERNOR'S AWARD?	The Governor's Wellness Award was developed to help organizations of all sizes across the state of Nebraska become recognized for their wellness efforts. WHY SHOULD AN ORGANIZATION OR SCHOOL APPLY?	To receive statewide recognition for the worksite, organization, hospital, or school's wellness efforts. Plus, it's a great recruitment and retention tool.
WHO CAN APPLY?	Any organization or school that is supporting their employees with exceptional wellness programs. Three different levels are available: Sower, Grower, and Harvester.
WHERE CAN I FIND THE APPLICATION?	Access the application on the Panhandle Worksite Wellness Council website. Click <u>here</u> to access.
HOW DO I RECEIVE ADDITIONAL ASSISTANCE OR FEEDBACK?	Contact Nicole at nberosek@pphd.ne.gov or 308-279-3496 to ask questions or schedule an in-person or virtual connection.
HOW AND WHEN WILL WE RECEIVE RECOGNITION?	All award recipients will be formally notified by the Governor and receive a framed certificate. The organization or school will be recognized publicly at a banquet.
HOW LONG WILL THE CERTIFICATE BE VALID?	The award is valid for three years. Please reapply to receive the next level award.
WHAT IS THE COST TO APPLY?	There is no cost to apply.
WHAT IS NEW IN 2024?	All organizations or schools complete one application! Based on how many points earned will depend on which award level your organization or school will receive.

Complete the <u>application</u> and based on how many points your organization or school receives will determine which level your entity will achieve: sower, grower, or harvester award.

- Sower = 25-33 points
- Grower = 34 39 points
- Harvester = 40+ points
