Medicare log in is changing to help prevent fraud and ensure you're the only one who can access your information Medicare has partnered with three leading identity verification services—ID.me, CLEAR and Login.gov. These services are all free to use. If you already use one of these trusted services with another government agency, like the IRS or Social Security, you can use your existing, ID.me, CLEAR or Login.gov account to log in to your Medicare account.

Note: At this time, you can still use your username and password from when you created your Medicare account. Eventually you will only be able to use one of the three new services listed above.

Temporary increase of 8% will be **in effect April 26 through Jan. 17, 2027**

Priority Mail

Packages weighing 2 or more pounds will start at \$11.00

Priority Mail Express

Prices will start at \$35.65.

USPS Ground Advantage

Prices will start at \$7.90

Forever stamp prices expected to go up – again

2. Sign in using your myAlaska username and password. (if you don't have a myAlaska username and password, you will need to establish these prior to using myRnB)
3. Once signed in, you will be taken to the myRnB portal page.
4. If this is your first time logging on to myRnB, you need to verify your Last Name, Date of Birth, and the Last 4 digits of you Social Security Number, then click "Next".
5. Once successfully logged in you will see the myRnB landing page. Look to the left and Click "myDocuments" near the top of the screen. Here, you will find your direct deposit confirmations titled "Warrants", annual tax documents, and other documents related to your account.
6. Be SURE TO LOG OUT, NOT just close the window.

3 Big Medicare Prescription Drug Changes Coming in 2026

➤ **10 Part D drugs selected for new lower prices:**

Eliquis, for blood clot prevention and treatment

Enbrel, for rheumatoid arthritis, psoriasis and psoriatic arthritis

Entresto, for heart failure

Farxiga, for diabetes, heart failure and chronic kidney disease

Fiasp and NovoLog, types of insulin for diabetes

Imbruvica, for blood cancers

Januvia, for diabetes

Jardiance, for diabetes, heart failure and chronic kidney disease

Stelara, for psoriasis, psoriatic arthritis, Crohn's disease and ulcerative colitis

Xarelto, for blood clot prevention and treatment

➤ **Out-of-pocket drug costs will be capped at \$2,100**

The maximum Part D deductible will also increase in 2026, to \$615, up from \$590 in 2025.

➤ **Medicare to cut cost of popular weight-loss drugs**

Medicare beneficiaries enrolled in part D prescription plans through either original Medicare or Medicare Advantage will see GLP-1 weight-loss drugs available at \$50 a month for those who qualify.

5 Changes Coming to the Post Office in 2026

1 Pay more for shipping

On Jan. 18, the price of several postal services will increase

➤ **Priority Mail** prices will rise by 6.6% on average

➤ **Priority Mail Express** prices will increase by 5.1%

➤ **USPS Ground Advantage** prices will jump 7.9%

2 Forever stamp prices are expected to go up in mid-2026

3 New stamp designs celebrate art, pop culture icons, symbols of America and outer space

4 Your mail may take longer to be postmarked (see time-sensitive mail below)

5 You might not receive exact change when paying with cash (following the 1-cent coin's retirement in 2025, the USPS is rounding to the nearest nickel when pennies aren't available and customers are owed change on cash transactions. Change amounts ending in 1, 2, 6, 7 cents are rounded down. Amounts ending in 3, 4, 8, 9 cents are rounded up. If the total is less than a nickel, the amount owed is rounded up to 5 cents.

The new round policy, was implemented on Dec. 12, 2025 and does not apply to check, debit or credit card transactions.

TEACH Fellowship 2026-2027 Teach in Taiwan, Applications Open. The TEACH Fellowship (Teach English Abroad and Change Happens) is an international teaching fellowship organized by the Association for International Cultural and Educational Exchange (AICEE). You must get a manual hand-stamped POSTMARK at a post office counter or mail items several days early for processing before your deadline; Certified/Registered Mail provides dated receipts but not necessarily the date of mailing.

In essence: the USPS is focusing on processing efficiency, and this change clarifies that the postmark is the processing date, not a drop-off date, requiring proactive steps from you for time-sensitive mail.

December 2025

6 Significant Medicare Changes in 2026:

- 1 Projected Part A (individuals without sufficient work history, projected to increase to \$310 or \$563/month) and B (projected standard increase to \$206.50/monthly premium). The Part B deductible is expected to increase to \$288 next year.
- 2 Prescription Payment Plans will Auto-Renew
- 3 Drug Costs Rise: Out-of-pocket cap for Medicare Part D prescription drugs will rise to \$2,100, up from \$2,000 in 2025. This change means you'll pay more before reaching the catastrophic coverage threshold, so it's wise to review your plan to see how high-cost medications are covered.

Part D plans will see another hike in their maximum deductible, climbing to \$615 in 2026. Keep in mind that plans can choose to have a lower deductible amount, so be sure to check your you plan provider for updated amounts.
- 4 Medicare Advantage Plans Face Stricter Rules on Extra Benefits (Alaska does not have Medicare Advantage Plans): What can be offered under their Special Supplemental Benefit for the Chronically III (SSBCI). In 2026, CMS will enforce a list of non-allowable items.

5 Free Vaccines Continue for Medicare Beneficiaries: Continue to offer zero cost-sharing for adult vaccines recommended by the CDC's Advisory Committee on Immunization Practices (ACIP). This includes critical vaccines like shingles, pneumonia, and flu shots.

This benefit will remain in effect permanently. However, keep in mind that the list of covered vaccines may change each year, so always double-check before scheduling immunizations.

6 Prior Authorizations (**PA**) Coming to Original Medicare in Select States: For the first time, traditional Medicare will implement prior authorization requirements in six states—Arizona, New Jersey, Ohio, Oklahoma, Texas, and Washington—as part of the new (Wasteful and Inappropriate Service Reduction) **WISeR** Model beginning January 1, 2026. Targeting fraud/waste via AI/tech with human oversight, impacting pain management, orthopedics, and wound care, requiring more provider admin but aiming to save money and improve care by stopping low-value treatments, a major shift for Traditional Medicare.

This initiative will use technology to speed up authorization for select services. Importantly, final decisions will be made by licensed clinicians, not AI systems. While some may view this as added red tape, the goal is to reduce wasteful or unnecessary procedures while protecting taxpayer dollars.

COLA for 2026 has a 2.8% (or 0.028) increase Starting January 2026. If you have a My Social Security account, you can view your COLA notice online in your message center starting around **November 19, 2025**. SSA begins mailing official notices in early December 2025, which will detail your new benefit amount.

Medicare's Income Related monthly Adjustment Amount, **IRMAA**, is based on your 2024 tax return to find your Modified Adjusted Gross Income (MAGI) and using projected 2026 brackets and surcharges. The official 2026 IRMAA amounts will be released in the fall of 2025 via your **Social Security account** and a notice in the mail (3rd week in Nov.), so you will not know your exact increase until then.

► Update to remove member coinsurance for diagnostic colonoscopies received in-network

Update the following under the **Standard Dental-Vision-Audio Plan (DVA)**

- Increase coverage from 2 to 4 prophylaxis, scaling, and periodontal maintenance visits per calendar year, and remove Delta Dental's Oral Health Total Health program.
- Allow coverage for 3D dental imaging once per calendar year.
- Increase the allowance for the topical application of fluoride from 2 times per calendar year based on age criteria, to 4 times per calendar year with no age limit. Remove current eligibility criteria for sealant application, sealant repair, preventive resin restoration in a moderate to high carries risk patient for a permanent tooth and allow once per tooth per year for each service.
- Reduce the crown frequency limit from once per tooth every 7 years, to once per tooth every 5 years, and update the reimbursement allowance from the allowable amount for a **metal crown**, up to the allowable amount for a **porcelain crown**.

On **March 5, 2025, Wednesday**, members affected by the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO) began receiving their

one-time retroactive payment, deposited into the bank account Social Security Administration has on file for you.

The one-time retroactive **payment will date back to January 2024**, the month when WEP and GPO no longer applied.

Social Security benefits are paid one month behind, so **most affected beneficiaries will begin receiving their new monthly benefit amount in April 2025** (for their March 2025 benefit).

Remember there are **3 areas the Social Security Fairness Act might effect:**

2025 **Taxes** that we will file in 2026

Your SSA 1099 Form for 2025 (will have this information)

Medicare Premiums by moving RETIREES into a higher tax bracket, potentially trigger IRMAA surcharges

IRMAA is based on a two-year lookout, the 2025 increase could **affect premiums starting in 2027**

I put 2 documents on your table, **one from Kiplinger**, the **other document** begins with: **Social Security update Mar. 3 on the Fairness Act**

The House passed the Bill by an overwhelming majority of 327-75. President Biden signs H.R. 82 on Sunday, Jan. 5, 2025.
