### PART A. CRIMINAL INDICTMENTS

COMES NOW, Kennedy Foster, acting Private Attorney General for, and on behalf of the Plaintiff, THE TEMPLE OF UNIVERSAL GOD CONSCIOUSNESS, a sentient being entity, and for good cause shown files this Criminal Indictment, against the biblical Defendant, THE APOSTLE PAUL DOE, *aka* SAUL, a self proclaimed biblical prophet (last name unknown) on the following grounds to wit:

- 1. This is a *nunc pro tunc* Criminal Indictment against the biblical Defendant, THE APOSTLE PAUL DOE, aka, SAUL, seeking a felony criminal indictment charges on information and facts as follows:
  - (1) **Count One** Proceeding as a false Prophet on behalf the Christian Messiah Jesus Christ with intent to deceive religious believers under a fictitious name and identity;
  - (2) **Count Two** Blasphemy in the name of the Judeo-Christian Messiah Jesus Christ, Christianity's proclaimed risen savior;
  - (3) **Count Three** Crimes against Humanity in the forced acceptance of a religion called Christianity resulting in the death and destruction of more than 70 Million men, women and children in a span of 700 year and to date;
  - (4) **Count Four** The predatory manipulation of human emotion in the preaching of religious doctrine using fear, duress, deception, trickery and guile to gain the non-believers favor;

(5) **Count Five** - Insighting ongoing insurrections that have lead to greater than severn centuries of religious conflicts and wars causing the unecessary death and destruction of millions of sentient beings;

2. All charges stated against the criminal defendant shall be tried in the temple of human consciousness and discernment and shall be governed by the "King James Version" of the biblical text, the King James Dictionary and The Blue Letter Bible Concordance, and the Federal Rules of Criminal Procedure and Federal Rules of Evidence unless otherwise stated and agreed heretofore and such other acts that may be revealed in the course of prosecution.

#### PART B.

#### RESERVATION OF RIGHTS TO BRING ADDITIONAL CRIMINAL CHARGES

Plaintiff, THE TEMPLE OF UNIVERSAL GOD CONSCIOUSNESS, by and through counsel herein reserves the right to amend this Criminal Indictment against the biblical Defendant to add additional charges in light of the current conflict between Israeli-Palestinian which the Defendant may be a party. The conflict involves religious, political and territorial disputes that the Plaintiff believes is directly connected to the Defendant. The conflict has led to periodic outbreaks of violence, with both sides experiencing casualties and suffering, all in the name of religious BELIEF that appears favorable to their situs.

## PART C. KING JAMES VERSION BIBLICAL DEFINITIONS

2.1. For confirmation, continuity and a mutual understanding of words, terms and phrases, the following definitions are provided and derived from the King James Version Dictionary online at <a href="https://av1611.com/">https://av1611.com/</a> and shall the used as the primary tool to establish the meaning of words as used in the scriptures as it relates to this criminal indictment of the biblical Defendant.

**BELIEF:** A persuasion of the truth, or an assent of mind to the truth of a declaration, proposition or alleged fact, on the ground of evidence, distinct from personal knowledge; as the belief of the gospel; belief of a witness. Belief may also by founded on internal impressions, or arguments and reasons furnished by our own minds; as the belief of our senses; a train of reasoning may result in belief. Belief is opposed to knowledge and science.

**BEWARE:** Literally, to restrain or guard one's self from. Hence, to regard with caution; to restrain one's self from anything that may be dangerous, injurious or improper; to avoid; to take care; followed by of before the thing that is to be avoided.

**CHRIST:** an appellation given to the Savior of the World, and synonymous with the Hebrew Messiah, which is yet to come. It was a custom of antiquity to consecrate persons to the sacerdotal and regal offices by anointing them with oil.

**CRAFTY:** Cunning, art or skill, in a bad sense, or applied to bad purposes; artifice; guile; skill or dexterity employed to effect purposes by deceit

**DECEIVED:** Misled; led into error; beguiled; cheated; deluded.

**FALSE:** Not true; not conformable to fact; expressing what is contrary to that which exists, is done, said or thought. A false report communicates what is not done or said. A false accusation imputes to a person what he has not done or said. A false witness testifies what is not true. A false opinion is not according to truth or fact. The word is applicable to any subject, physical or moral

**GOD:** The Supreme Being; Jehovah; the eternal and infinite spirit, the creator, and the sovereign of the universe.

**GUILE**: Craft; cunning; artifice; duplicity; deceit; usually in a bad sense.

**FAITH**: Belief; the assent of the mind to the truth of what is declared by another, resting on his authority and veracity, without other evidence; the judgment that what another states or testifies is the truth. I have strong faith or no faith in the testimony of a witness, or in what a historian narrates. 2. *The assent of the mind to the truth of a proposition advanced by another*; belief, or probable evidence of any kind.

**GOS'PEL:** The history of the birth, life, actions, death, resurrection, ascension and doctrines of Jesus Christ; or a revelation of the grace of God to fallen man through a mediator, including the character, actions, and doctrines of Christ, with the whole scheme of salvation, as revealed by Christ and his apostles. This gospel is said to have been preached to Abraham, by the promise, "in thee shall all nations be blessed." Ga.3.8.

**PROPHET:** One that foretells future events; a predicter; a foreteller; In Scripture, a person illuminated, inspired or instructed by God to announce future events; as Moses, Elijah, David, Isaiah, &c. An interpreter; one that explains or communicates sentiments. Ex.7. One who pretends to foretell; an imposter; as a false prophet. Acts 13.

**SUPERSTITION:** Excessive exactness or rigor in religious opinions or practice; extreme and unnecessary scruples in the observance of religious rites not commanded, or of points of minor importance; excess or extravagance in religion; the doing of things not required by God, or abstaining from things not forbidden; or the belief of what is absurd, or belief without evidence.

**VISION:** Something imagined to be seen, though not real; a phantom; a specter. In Scripture, a revelation from God; an appearance or exhibition of something supernaturally presented to the minds of the prophets, by which they were informed of future events. Such were the visions of Isaiah, of Amos, of Ezekiel, &c.

**WICKEDLY:** In a manner or with motives and designs contrary to the divine law; viciously; corruptly; immorally

WRETCH: A miserable person; one sunk in the deepest distress; as a forlorn wretch.

**WISDOM:** The right use or exercise of knowledge; the choice of laudable ends, and of the best means to accomplish them. This is wisdom in act, effect, or practice. If wisdom is to be considered as a faculty of the mind, it is the faculty of discerning or judging what is most just, proper and useful, and if it is to be considered as an acquirement, it is the knowledge and use of what is best, most just, most proper, most conducive to prosperity or happiness.

3.1 The above definitions are directly from the online KJV Dictionary and can be easily accessed. Whereas, it is hereby established and agreed that said words, terms and phrase may be referenced heretofore throughout this criminal indictment against the Defendant.

### PART D. BACKGROUND OF THE CRIMINAL DEFENDANT APOSTLE PAUL

- 2.2. Defendant, and self-proclaimed APOSTLE PAUL DOE, also known as Saul of Tarsus, is described in the New Testament as a Jew. He was born in Tarsus, a city in the region of Cilicia (in modern-day Turkey), which was part of the Roman Empire. In terms of ethnicity and religious background, Paul identified himself as a Jew, and he was a Pharisee, a strict sect within Judaism, before his conversion to Christianity.
- 2.3. In his own writings in the New Testament, the Defendant Paul refers to his Jewish heritage in the New Testament of King James Bible, book of Philippians, as a Hebrew of the Hebrews in his epistles at Philippians 3:4-5: 'Though I might also have confidence in the flesh. If any other man thinketh that he hath whereof he might trust in the flesh, I more: Circumcised the eighth day, of the stock of Israel, of the tribe of Benjamin, an Hebrew of the Hebrews; as touching the law, a Pharisee.," confirmation of the Defendant's intrabiblical Jewish roots. The criminal Defendant claims to have converted to Christianity and became the voice of the Judeo-Christian Messiah Jesus Christ. See John 4:25-26 (KJV) "The woman saith unto him, I know that Messias cometh, which is called Christ: when he is come, he will tell us all things. Jesus saith unto her, I that speak unto thee am he." (

# PART E. THE EPISTLES OF THE APOSTLE PAUL AKA SAUL

2.4. Defendant, and self-proclaimed APOSTLE PAUL DOE, is believed to have written his letters (epistles) during roughly the same time frame as the Gospels, decades following the death and resurrection of Christian Messiah Jesus Christ. His earliest letters, such as 1 Thessalonians and Galatians, are thought to have been written in the 50s CE, while his later letters, such as 2 Timothy, are dated to the 60s CE / AD (Common Era). Therefore, Paul's writings predate the

Gospel narratives. The Defendant is traditionally credited with writing 13 of the books in the New Testament of the Bible. A list of these books. Include, but is not limited to: Romans, 1 Corinthians, 2 Corinthians, Galatians, Ephesians, Philippians, Colossians, 1 Thessalonians, 2 Thessalonians, 1 Timothy 2 Timothy, Titus and Philemon.

2.5. The Defendant Apostle Paul having alleged to take credit for the above writings, letters and the claims made therein, sufficient to effect the consciousness of five (5) billion sentient beings, is heretofore held accountable for such claims, *nunc pro tunc*.

# PART F. SAUL CLAIMS OF A VISION IN DAMASCUS, CONVERTS TO CHRISTIANITY AND CHANGES HIS NAME TO PAUL

- 2.6. It is hereby summarized and affirmed that the Defendant APOSTLE PAUL DOE is recorded as making the following intrabiblical statements of such nature against his best interest as follows: Acts 9:1-19 (KJV): "Once claiming slaughter against the disciples of the Lord, as the Defendant journeyed near Damascus, he had a vision from Jesus, who told Saul to go into the city, and it shall be told thee what thou must do. From the vision, Saul claims to have been without sight for three days, and neither did eat nor drink."
- 2.7. The Defendant does not explicitly mention a specific moment when Saul's changed his name to Paul. But Saul, the persecutor of Christians prior to the claimed vision, is now Paul, self-proclaimed advocate of the current day biblical Christian Messiah Jesus Christ, *aka*, Yeshu Ha-Mashiach (Hebrew) and Iesous Christos, (Greek), hereinafter referred to as Jesus Christ. Additionally, it must be noted that Jesus Christ of the bible is not a Christian, he was said to be of Jewish nomenclature.

## PART G. BIBLICAL LEGAL STANDARDS GOVERNING FALSE PROPHETS

2.8. The King James Version (KJV) of the bible contains multiple warnings about false prophets. These verses emphasize the importance of discernment and caution when it comes to evaluating the messages of individuals claiming to be prophets. They remind believers to test the spirits and teachings to ensure they align with the truth revealed in the scriptures. These passages will be referenced in the Criminal Indictment against the Defendant to expose his violation of the same. Here are a few scriptures from the King James Version governing biblical law to wit:

Deuteronomy 13:1-5 (KJV): "If there arise among you a prophet, or a dreamer of dreams, and giveth thee a sign or a wonder, And the sign or the wonder come to pass,

whereof he spake unto thee, saying, Let us go after other gods, which thou hast not known, and let us serve them; Thou shalt not hearken unto the words of that prophet, or that dreamer of dreams: for the Lord your God proveth you, to know whether ye love the Lord your God with all your heart and with all your soul. Ye shall walk after the Lord your God, and fear him, and keep his commandments, and obey his voice, and ye shall serve him, and cleave unto him. And that prophet, or that dreamer of dreams, shall be put to death; because he hath spoken to turn you away from the Lord your God..." Deuteronomy 18:20 (KJV): "But the prophet, which shall presume to speak a word in my name, which I have not commanded him to speak, or that shall speak in the name of other gods, even that prophet shall die." Jeremiah 14:14 (KJV): "Then the Lord said unto me, The prophets prophesy lies in my *name*: I sent them not, neither have I commanded them, neither spake unto them: *they* prophesy unto you a false vision and divination, and a thing of nought, and the deceit of their heart." Matthew 7:15 (KJV): "Beware of false prophets, which come to you in sheep's clothing, but inwardly they are ravening wolves." Matthew 24:24 (KJV): "For there shall arise false Christs, and false prophets, and shall shew great signs and wonders; insomuch that, if it were possible, they shall deceive the verv elect." 2 Peter 2:1 (KJV): "But there were false prophets also among the people, even as there shall be false teachers among you, who privily shall bring in damnable heresies, even denying the Lord that bought them, and bring upon themselves swift destruction." 1 John 4:1 (KJV): "Beloved, believe not every spirit, but try the spirits whether they are of God: because many false prophets are gone out into the world." Matthew 24:11 (KJV): "And many false prophets shall rise, and shall deceive many." **Jeremiah 23:16 (KJV):** "Thus saith the Lord of hosts, Hearken not unto the words of the

prophets that prophesy unto you: they make you vain: they speak a vision of their own heart, and not out of the mouth of the Lord."

- 2 Corinthians 11:13-15 (KJV): "For such are false apostles, deceitful workers, transforming themselves into the apostles of Christ."
- 2.9. The above passages are being used in this criminal Indictment against the Defendant THE APOSTLE PAUL DOE under the doctrine of false prophets as canonized in the King James Version of the bible admissions against interest. The Defendant having made multiple incriminating statements including but not limited to being a liar, untrustworthy, deceitful, sinful,

evil warring against the law of his mind and that no good thing dwelleth in him, cannot be ignored. Ignoring these statements and his acts that follow would be a travesty of justice.

#### PART H.

# DEFENDANT'S ADMISSION AGAINST INTEREST AND A FALSE PROPHET IS DOCUMENTED, CLEAR AND COGENT AND STATED IN HIS EPISTLES

2.10. The Defendant, APOSTLE PAUL DOE, is believed to have written his letters (epistles) during roughly the same time frame as the Gospels, decades following the death and resurrection of Jesus. Having made said admissions, we must consider the plain language of the Defendant statements as shall be presented in the preceding allegations. WHEREAS, the Defendant is credited for making the following incriminating statements "according to his gospel" per his own documented writings, lest he present witness to testify otherwise on his behalf:

**Romans 2:16** (KJV) In the day when God shall judge the secrets of men by Jesus Christ *according to my gospel*.

Romans 16:25 Now to him that is of power to establish you <u>according to my gospel</u>, and the preaching of Jesus Christ..."

2 Timothy 2:8 Remember that <u>Jesus Christ of the seed of David</u> was raised from the dead <u>according to my gospel</u>:

Romans 3:7 (KJV) For if the truth of God hath more abounded through my lie unto his glory; why yet am I also judged as a sinner?

**Philippians 1:18 (KJV)** What then? **notwithstanding, every way, whether in pretense, or in truth**, Christ is preached; and I therein do rejoice, yea, and will rejoice." (Here Paul is saying it does not matter whether I'm telling you a lie or the truth, I'm preaching Christ.)

1 Corinthians 15:14 "And if Christ be not risen, then is our preaching vain, and your faith is also vain."

Corinthians 12:16-17 But be it so, I did not burden you: nevertheless, being crafty, I caught you with guile. Did I make a gain of you by any of them whom I sent unto you?

Romans 7:14-24 For we know that the law is spiritual: but I am carnal, sold under sin.

15 For that which I do I allow not: for what I would, that do I not; but what I hate, that do I.

16 If then I do that which I would not, I consent unto the law that it is good.17 Now then it is no more I that do it, but sin that dwelleth in me. 18 For I know that in me (that is, in my flesh,) dwelleth no good thing: for to will is present with me; but how to perform that which is good I find not. 19 For the good that I would I do not: but the evil which I would not, that I do. 20 Now if I do that I would not, it is no more I that do it, but sin that dwelleth in me. 21 I find then a law, that, when I would do good, evil is present with me. 22 For I delight in the law of God after the inward man: 23 But I see another law in my members, warring against the law of my mind, and bringing me into captivity to the law

<u>of sin</u> which is in my members. 24 <u>O wretched man that I am</u>! who shall deliver me from the body of this death?

Galatians 1:11-19 <u>But I certify you</u>, brethren, that the gospel which was preached of me is not after man. 12 For <u>I neither received it of man</u>, neither was I taught it, but by the revelation of Jesus Christ. 17 <u>Neither went I up to Jerusalem to them which were apostles</u> before me; but I went into Arabia, and returned again unto Damascus.

Galatians 2:7 (KJV) But contrariwise, when they saw that the gospel of the uncircumcision was committed unto me, as the gospel of the circumcision was unto Peter;

Galatians 5:2-4 (KJV): "Behold, I Paul say unto you, that if ye be circumcised, Christ shall profit you nothing. For I testify again to every man that is circumcised, that he is a debtor to do the whole law. Christ is become of no effect unto you, whosoever of you are justified by the law; ye are fallen from grace."

2 Peter 3:15-17 (KJV) And account that the long suffering of our Lord is salvation; even as our beloved brother Paul also according to the wisdom given unto him hath written unto you; 16 As also in all his epistles, speaking in them of these things; in which are some things hard to be understood, which they that are unlearned and unstable wrest, as they do also the other scriptures, unto their own destruction. 17 Ye therefore, beloved, seeing ye know these things before, beware lest ye also, being led away with the error of the wicked, fall from your own stedfastness.

2.11. The above passages are being used in this criminal Indictment against the Defendant the APOSTLE PAUL DOE under the doctrine of admissions against interest. The Defendant having made multiple incriminating statements including but not limited to being a liar, untrustworthy, deceitful, sinful, evil warring against the law of his mind and that no good thing dwelleth in him cannot be ignored. Ignoring these statements and his acts that follow would be a travesty of justice.

2.12. Additionally we must also take heed of the warning that the Apostle Peter sincerely expressed with his concerns after the criminal Defendant came to visit him three years after the death of Christ. Peter gave a clear and cogent warning that anyone listing to Paul's teachings which are unlearned, unstable and twisted, may be deceived to your own destruction.

#### PART I. CRIMIAL INDICTMENTS OF THE APOSTLE PAUL

# CRIMINAL INDICTMENT COUNT I. (a.) <u>DEFENDANT IS HEREBY CHARGED WITH THE CRIME MASS DECEPTION</u> BEING A FALSE PROPHET WITHIN THE MEANING OF THE KING JAMES BIBLE

3.2 Plaintiff re-allege the foregoing and incorporate by reference each and every allegation as set forth and enumerated herein *supra*, and further allege the following:

- 3.3 Plaintiff files this criminal indictment against the Defendant APOSTLE PAUL DOE under the doctrine of "false prophets" as canonized within the meanings of the King James Version (KJV) of the bible in that the Defendant's conduct was of such nature to influence the consciousness of those that believed his words.
- 3.4 Question of Biblical Law I: Does the bible define, prohibit and punish for the crime of being a false prophet? We must answer in the affirmative. See also Deuteronomy 18:20 (KJV) which states in part: "But the prophet, which shall presume to speak a word in my name, which I have not commanded him to speak .. shall die." 2 Corinthians 11:13-15 (KJV): "For such are false apostles, deceitful workers, transforming themselves into the apostles of Christ." Deuteronomy 13:1-5 (KJV): "If there arise among you a prophet, or a dreamer of dreams, and giveth thee a sign or a wonder, and that prophet, or that dreamer of dreams, shall be put to death; because he hath spoken to turn you away from the Lord your God..." Please see 2.4 "Biblical Legal Standards Governing False Prophets" citing multiple passages warning of false prophets.
- 3.5 That the Defendant did not consult any of the twelve disciples, faithful followers of Jesus Christ to share with them the vision he alleged to have had on the road to Damascus although he had the opportunity to do so upon his visit with Peter and James, Jesus's brother.
- 3.6 Per his own statements, the criminal Defendant proceeded in bad conscious and with evil intent, guile, deception and misrepresentation of material facts with intent to deceive and mislead believers in an effort to gain favor in his teaching of these falsehoods.
- 3.7 In the execution of his criminal acts and intent to decieve many, the Defendant stood in the midst of Mars' hill, and said, Acts 17:22-23 "Ye men of Athens, *I perceive that in all things ye are too superstitious (religious)*. For as I passed by, and beheld your devotions, *I found an altar with this inscription, To The Unknown God*, Whom therefore ye ignorantly worship, him declare I unto you," and thereafter the Defendant began to profess of a God that made the world and all things therein, and falsely claiming that God dwelleth not in temples.
- 3.8 The criminal Defendant, passing judgment upon the men of Athens, who rightfully gave reverence to an "Unknown God" for which they understood the meaning espoused in Isaiah 55:8-9 KJV which states, "For my thoughts are not your thoughts, neither are your ways my ways. For as the heavens are higher than the earth, so are my ways higher than your ways, and my thoughts than your thoughts." and honored God in such manner and with just respect.

- 3.9 That the Defendant boast of his false prophecy is specifically stated by Peter, one of the Twelve disciple of Jesus Christ, who, concerned with the teachings of the Defendant and his delusional state warned at 2 Peter 3:15-17 "... even as our beloved brother Paul ... according to the wisdom given unto him hath written unto you, As also in all his epistles, speaking in them of these things; in which are some things hard to be understood, which they that are unlearned and unstable wrest, as they do also the other scriptures, unto their own destruction," now that I have made you aware of Paul's teachings, beware lest ye also, being led away with the error of the wicked, fall from your own stedfastness", further affirming the Defendant's teachings as a false prophet as defined within the meanings of scriptures.
- 3.10 Approximately 30 years or after the death of the Christian Messiah Jesus Christ, and with the intent to deceive many, the Defendant APOSTLE PAUL DOE (alias SAUL), claimed to have had a vision from the Messiah while traveling near Damascus, who told Saul in that vision to <u>go</u> <u>into the city, and it shall be told thee what thou must do</u>, committed blasphemy having made unverifiable claims in contradiction of the same.
- 3.11 As part of the deception, the criminal Defendant APOSTLE PAUL DOE, changed his name from SAUL to PAUL, knowing that he would return to deceive many under a false identity.
- 3.12 In the mass deception and intent to deceive many the Defendant states in pertinent part, being crafty, he caught believers with guile in the claim that he made seeing Jesus Christ in a vision on the road to Damascus, and having gained additional believers to follow the teachings of Christ the Defendant boasted that he made gain in his deception, See *Corinthians* 12:16-17.
- 3.13 In the mass deception the Defendant claims at *2 Timothy 2:8* that Jesus Christ was raised from the dead *according to his gospel*, and not the gospel of his disciples, Matthew, Mark, Luke and John, as alleged in his vision.
- 3.14 In an admission against interest disclosing his intent to deceive many, the criminal Defendant boast that his lies as a false prophet having more abounded believers to God, he should not be judged as a sinner. *See Romans 3:7*
- 3.15 The Defendant further stated at *Philippians* 1:18: that he would preach Jesus Christ name *whether he preach the lie or the truth* in the process of deceiving many. *Id*
- 3.16 As a direct and proximate cause of the Defendant's conduct including but not limited to the criminal intent to deceive many, trick his victims with guile in an effort to convert them to Christianity, with malicious intent to mislead to gain favor in the teachings of these falsehoods,

Plaintiff demands that the criminal Defendant be punished the maximum allowed under biblical law. Having proceeded in reckless disregard for the whole of humanity and creating religious zealots willing to kill and die in the name of religious belief, and having successfully deceived many, the criminal Defendant's biblical punishment as a false prophet is death.

**WHEREFORE**, Plaintiff demands a VERDICT of GUILTY AS CHARGED in Count I of this criminal Indictment to meet the ends of justice and such other relief as the Court deems just and proper.

#### CRIMINAL INDICTMENT COUNT II.

## (b.) <u>DEFENDANT IS CHARGED WITH THE CRIME OF MASS DECEPTION AND</u> BLASFEMY IN THE NAME OF JESUS CHRIST WITH HIS INTENT TO DECIEVE

- 3.17 Plaintiff re-allege the foregoing and incorporate by reference each and every allegation as set forth and enumerated herein *supra*, and further allege the following:
- 3.18 Plaintiff files this criminal indictment against the Defendant APOSTLE PAUL DOE *mass deception* and blasphemy as result of being a false prophet as defined within the meanings of the King James Bible in that the Defendant's conduct proceeded within intent to deceive many, and trick the deceived with guile, in an effort to gain favor in the teachings of these falsehoods.
- 3.19 **Question of Biblical Law II:** Did the Criminal Defendant, APOSTLE PAUL DOE, make statements and claims in writing with intent to deceive many, which have successfully come to fruition for the greater of 2,000 years? We must answer in the affirmative.
- 3.20 In the mass deception and intent to deceive many the Defendant states at **Corinthians**12:16-17 in pertinent part: "But be it so, I did not burden you: nevertheless, being crafty, I caught you with guile," knowing the vision the criminal Defendant is alleged to have had of the Messiah on the road to Damascus, was a trick to gain additional believers to Christianity, in the fowarding of his false prophecy.
- 3.21 The criminal Defendant states at "Then after three years I went up to Jerusalem to see Peter and abode with him fifteen days", and met with the Apostle James the Lord's brother." Galatians 1:18-19. In the meeting with Peter, the Defendant APOSTLE PAUL DOE did not once or at anytime time mentions that he had a vision of Jesus Christ, who, in the vision on the road to Damascus, authorized and empowered the Defendant preach Christianity to the Gentiles.
- 3.22 The Apostle Peter, one of the Twelve disciple of Christ, after being visited by the Defendant APOSTLE PAUL DOE, became deeply disturbed and concerned about what was said in the meeting by the Defendant apparently indicating that he would deceive many.

3.23 Having witnessed the Defendant's delusions first hand, Peter stated and warned at 2 Peter 3:15-17 "... even as our beloved brother Paul ... according to the wisdom given unto him hath written unto you, As also in all his epistles, speaking in them of these things; in which are some things hard to be understood, which they that are unlearned and unstable wrest, as they do also the other scriptures, unto their own destruction," now that I have made you aware of Paul's teachings, beware lest ye also, being led away with the error of the wicked, fall from your own stedfastness." Peter clearly stated that the Defendant wrote unto you according to the "wisdom given unto him," yet in no way indicated that said wisdom came from a vision he claims to have had from Jesus Christ.

- 3.24 The self-appointed criminal Defendant's deception has had long-term and lingering consequences in the consciousness of man and has heavily contributed to the senseless slaughter of millions of men, women and children in the name of Jesus Christ, *according to his gospel*, as stated in the Defendant's epistles.
- 3.25 As a direct and proximate cause of the Defendant's mass deception of many and other false claims as alleged herein, the Defendant's conduct was a conscious and malicious ploy to deceive many as a false prophet of Christian Messiah Jesus Christ, that has successfully confused and divided humanity across the globe.
- 3.26 Having proceeded in reckless disregard for the whole of humanity and creating religious zealots willing to kill and die in the name of religious belief, and having successfully deceived many, the crimimal Defendant's biblical punishment as a false prophet, if found guilty is death.
- **WHEREFORE,** Plaintiff demands a VERDICT of GUILTY AS CHARGED in Count II of this criminal Indictment to meet the ends of justice and such other relief as the Court deems just and proper.

#### CRIMINAL INDICTMENT COUNT III.

# (c.) <u>DEFENDANT IS CHARGED WITH THE CRIME OF MASS DECEPTION AND BLASFEMY IN THE NAME OF JESUS CHRIST WITH INTENT TO DECIEVE</u>

- 3.27 Plaintiff re-allege the foregoing and incorporate by reference each and every allegation as set forth and enumerated herein *supra*, and further allege the following:
- 3.28 Plaintiff files this criminal Indictment against the Defendant APOSTLE PAUL DOE for malicious intent to deceive many, wherein the Defendant committed blasphemy in the name of Jesus Christ, as the self-appointed prophet for the uncircumcised.

3.29 **Question of Biblical Law III:** Did the criminal Defendant act with malicious intent to deceive many and misrepresentation of material facts, wherein the Defendant committed blasphemy in the name of Jesus Christ, alleging *interalia*, that he had a vision from Christ on the road to Damascus that instructed the criminal Defendant abrogate the well established biblical law of circumcision, canonized in the bible as proffered by God in accordance with Jewish canons.

3.30 In the mass deception and intent to deceive many the Defendant states in his epistles at Galatians 2:7-8 (KJV): "when they saw that the gospel of the uncircumcision was committed unto me, as the gospel of the circumcision was unto Peter; 8 (For he that wrought effectually <u>in Peter to the apostleship of the circumcision</u>, the same was mighty in me toward the Gentiles:)

3.31 The law of circumcision was clearly established in Genesis 17:10-14 (KJV) under the authority of the biblical Almighty God through in so stating and affirming in part: "This is my covenant, which ye shall keep, between me and you and thy seed after thee; Every man child **among you shall be circumcised.** And the uncircumcised man child whose flesh of his foreskin is not circumcised, that soul shall be cut off from his people; he hath broken my covenant."

3.32 Prior to the death of Christ, he clearly told his disciples at Matthew 10:5-6 in so stating: "Go not into the way of the Gentiles (Europeans), and into any city of the Samaritans (mixed race) enter ye not: But go rather to the lost sheep of the house of Israel, clearly establishing they avoid the heathens.

3.33 As a direct and proximate cause of the criminal Defendant's mass deception with intent to deceive many per his statements in his epistles, the Defendant's conduct was a conscious, clear, cogent and malicious ploy to deceive many as a false prophet for the Christian Messiah Christian Messiah Jesus Christ, that has successfully confused and divided humanity across the globe, proceeded in reckless disregard for the whole of humanity and creating religious zealots from the Defendants false prophecy, that has resulted in absolute confusion, misinterpretation and misappication of biblical law.

3.34 Having proceeded in reckless disregard for the whole of humanity and creating religious zealots willing to kill and die in the name of religious belief, and having successfully deceived many, the crimimal Defendant's biblical punishment as a false prophet, if found guilty is death.

**WHEREFORE,** Plaintiff demands a VERDICT of GUILTY AS CHARGED in Count III of this criminal Indictment, a True Bill to meet the ends of justice and such other relief as the Court deems just and proper.

# CRIMINAL INDICTMENT COUNT IV. (d) <u>DEFENDANT IS CHARGED WITH CRIMES AGAINST HUMANITY WHICH</u> HAS LEAD TO THE DEATH AND DESTRUCTION OF PEOPLE AND NATIONS

- 3.35 Plaintiff re-allege the foregoing and incorporate by reference each and every allegation as set forth and enumerated herein *supra*, and further allege the following:
- 3.36 Plaintiff files this criminal Indictment against the Defendant APOSTLE PAUL DOE with crimes against humanity that has lead to the ongoing destruction of people and nations. for malicious intent to deceive many, wherein the Defendant committed blasphemy in the name of Christian Messiah Jesus Christ, as the self-appointed prophet for the uncircumcised.
- 3.37 The criminal Defendant APOSTLE PAUL DOE is responsible for Thirteen Books in the King James Bible as referenced hereinabove. The scriptures cited in those books are believed by over 4.5 billion religious Christians, Muslims and Jews combined to be the inspired word of God, prophized through man.
- 3.38 Because the claims made by Jewish men in ancient text more than 2,000 years ago that the bible and other religious text written by people of unknown origin is believed to be the inspired word of God, these unverifiable claims bearing no empirical evidence to support such claims, have had a lasting negative effect on human consciousness, emotion, feelings and beliefs in its successful attempt to control human behavior.
- 3.39 **Question of Biblical Law IV:** Has the Criminal Defendant's intent to deceive many had a lasting effect on the consciousness, religious beliefs, division and confusion of people and nations throughout the world? We must answer in the Affirmative.
- 3.40 Over the centuries, the Euro-Gentile Greco-Roman Empire transitioned Judaism into Christianity, and plagiarized from numerous other religions as early as 4,500 BCE, predominantly Kemetic-Egyptian Spirituality. In the bloodiest of religious wars ever fought over a span of 700 years, the Euro-Gentile Greco-Roman Catholic Church rulers after conquering Egypt, have murdered, slaughtered, enslaved, maned and abused to convert non-believers with a loss of life beyond 70 million sentient beings in a span of 700 years to include men, women and children in the name and establishment of Christianity.

- From the alleged vision on the road to Damascus, Saul claims to have been without sight for three days, and neither did eat nor drink." Taking Peter testimony into consideration regarding the criminal Defendant's delusional statements, it is most likely he fell sick, which cause the Defendant to hallucinate and have visions believed to be real, and remained in that state having been without food or water for three days thereafter.
- 3.42 Prior to the death and alleged resurrection of the biblical Christian Messiah Jesus Christ, the Christian Messiah clearly told his disciples at Matthew 10:5-6: "Go not into the way of the Gentiles (Europeans), and into any city of the Samaritans (mixed race) enter ye not: But go rather to the lost sheep of the house of Israel", clearly establishing they avoid the heathens.
- 3.43 The criminal Defendant has had a direct impact on the worldview of over 2 billion Christians, which has caused the murder of more than 70 million sentient beings, destruction of marriages, dis ownership of children, dissolution of friendships and never ending wars over land.
- 3.44 The criminal Defendant has a direct and indirect impact regarding relentless, deadly conflict between Israelis and Palestinians which has been going on for decades. The fighting has left thousands dead. Sometimes, the bloodshed has been set off by Israel targeting Palestinian leaders or responding to protests. Other times, it has been set off by attacks from Hamas or other militants.
- 3.45 The crimes against humanity for which the criminal Defendant is directly and indirectly liable comes at the heels of manipulation of the emotion and desire for man to believe in that which cannot be understood and induce other do the same.
- 3.46 As a direct and proximate cause of the criminal Defendant's mass deception and intent to trick his victims with guile per his own written statements in his epistles, the Defendant's conduct was a conscious and malicious ploy that deceived many as a false prophet of Christianity's Messiah Jesus Christ, that has successfully confused and divided humanity based on these religious practices across the globe.
- 3.47 Having proceeded in reckless disregard for the whole of humanity and creating religious zealots willing to kill and die in the name of religious belief, and having successfully deceived many, the criminal Defendant's biblical punishment as a false prophet, if found guilty is death.
- **WHEREFORE,** Plaintiff demands a VERDICT of GUILTY AS CHARGED in Count IV of this criminal Indictment, a True Bill to meet the ends of justice and such other relief as the Court deems just and proper.
