<u>Article 10</u> - Revised to add Article 10, PRIVACY, including and Sections 10.1 and 10.2, "Drones" and 10.3 "Prohibitions Against Trespass, Invasion of Privacy and Harassment".

<u>Article 11</u> - Revised to add Article 11, GENERAL, and Section 11.1 "Severability" and Section 11.2 "Waiver or Abandonment".
