This is, in general, the

30 first one I have is ready set go. Does anybody know what Ready set go? Is this for those that don't, and there's a couple of them that tell you all about it. Ready set go is a nationwide program. It's a it's a program devised to help people get ready to evacuate. Okay, if your zone, if we get a fire, a hazardous material incident, or anything that's major that's going to require evacuation. We will implement this system, and we will implement it by zones and areas. You will get notified you're in a ready position that's the time to be getting your stuff ready, figure out what you need, get your medicines together, get your pets

35 together, get your food together, and be ready to go if you get a set, just like when we're playing on the playground, Ready set go. When you get a set, it's going to be quite likely you're going to get a go. And that means get out now, okay, if you get a go order from anybody, including the fire department, law enforcement, be the sheriff's department, state police, BLM, us, Forest Service, law enforcement officers, you're being told to leave and go find a safe place to be. The Ready Set part is so you can get with your family members. Make sure you've got a plan on where you're going to go, where you're going to meet, how

40 you're going to keep in contact when you get there, you. And if there's any family members or friends you can contact outside this area that will help keep track of you and give you help at that time, when you get this we hope to be able to give you a place to go. But if it's something that's happening fast, and we got wildfire ripping through this area, it's just going to be get out. Okay, understand what that might be and where it comes from. We get into the code red area if you're not familiar with it. There's a paper here with the sheriff's department on it, and there's another one here that says Code Red. It is a third party it's

45 a third party application that you can sign up for through your computer or your smartphone, and it will register your cell phone to get reverse 911, calls. Reverse 911 calls will be general, I'm sorry, yes, sir, cool. It is very cool. And just a couple little things, what will happen on a reverse 911, if we get something now and I call or I asked one of my officers to call it Aspen,

notified dispatch. We have a code red situation in the Sugar Loaf area. Activate evacuation procedures, our dispatch center, our PSAP public safety answering point, which is in reserve, handling both law enforcement, fire and EMS, they will generate a recording out of their dispatch center, and it will automatically dial all landline phones in the area, automatic as long as you have a registered landline phone, if you don't have a landline phone, that's what code red is for. Is for registering your cell phones. Okay? It will register your cell phone so that you get some warning and advance notice of what's going on. On that recording that you'll get will be the instruction of where to go and what to do and how to get there. Okay, I think this is extremely important. I've been a member of Code Red for 20 years, and I like it. When you sign up for Code Red, you'll see that you get there online, if you can just search a code red on Google and it'll pop you up to on solve, which is a parent company. There's no charge, there's no advertising. There's nothing that's bothered me for 20 years. There's two ways you can sign up for Code Red. One, you can sign up for general notifications. The other one is emergency notifications. Do the emergency notification. If you sign up for general notifications, you're going to get Amber Alerts, missing people alert. You're going to get all kinds of stuff. You may get advertisements without doing that, if you just sign up for the emergency notifications, I can't guarantee, but I've not been bothered in 20 years by some random thing popping up on my phone. Yes, ma'am, if we

30 property. Law enforcement officer can't force you to leave your property. I can go up to you, sir, and say, Get out. Now you're in danger. Leave you. Say, No. I say, Okay. Thank you very much. Give me your name and address and I'll mark you down. I can't force you. I will mark it. I'll notify my dispatcher or my incident commander, and I'll keep that house in mind for if we have to go back up. But if the conflagration gets too drastic and I can't send firefighters in safely to rescue you, you are on your own. Understood. That's where we get the shelter in place. One second, please. That's where we get the shelter in place. If you
35 decide to stay there, learn how to shelter in place. That means that you're going to do whatever you can to protect yourself in the spot you're in, whether it be hide in the cellar, whether it be protect yourself with non flammable stuff around you, if you have an asbestos blanket you can throw over you, something of that nature, find the spot of your property and your home that is the most safest from the incident at hand. Okay, please evacuate. And please advise us when something initially pops up, and we have situations, as you described, where people are non ambulance, non ambulatory at the time, and can't really
40 move or take care of themselves. We want to try and get there as soon as we possibly can. And if I have to call further assistance from Socorro or Springerville, I'll do it. We will get people there, but we need to know ahead of time, and that means call dispatch. Dispatch has the administration number. You'll see that on your paperwork, 5336222, that's our business line for anything that's not an emergency, it's 911 if you're concerned about somebody's safety, that's a 911 if you want to call up and find out how the fire is doing. And hey, I wonder what my name that's not a 911 Okay, we have, we have limited
45 personnel. This entire county people limited personnel, and it. Everything we do, do you realize there's only, what, six or eight cops in this whole county? So we have limited personnel. Four. Keith is busy. Okay? We have limited dispatchers. There's one

on duty at a time. So when they're busy handling fire traffic, emergency medical traffic and law enforcement traffic all on the radio, because we're bugging them on the radio all the time, and then the phone's ringing off the hook. Be patient a little bit with them. They will get to the 911 calls before they'll answer it on the radio, and that's okay, because we need to take care of new incidents first. Yes, sir, I had a question.

If somebody's really in my way and won't leave, that's where my law enforcement person is going to go, and they will convince them.

What's a ladder fuel? I know somebody knows. Yeah. So limbs and stuff that touch the ground where the grass can get them and they can escalate up to get into the trees and start crowning and running on us. So we want to stop. Goes up about five feet, is what we would like to see. And that's around your house. The next one you want to look at is 100 feet away from your house. As I said, your zone two is 30 to 100 feet, and that's clearing that that first 30 feet of anything that's flammable, one of the situations I see a lot happens at my place is tumbleweeds blowing around, and they gather up under your porch, under your deck, under all those places that are really flammable, and they're going to go up like a Roman candle, aren't they, so that's one of the things. Ladder fuels, if we add some good grass fires right through here. All these trees are gone. Now I'm not expecting you to come out here and limb up all these trees. I'm giving you an idea what you can do around your house to protect it. One of our one of our huge problems is, which structure do we protect? The ones that are within, the ones that are defensible? Yes, ma'am, doesn't it make sense that we have to go the one. Defensible? It doesn't matter who it is. I don't care who lives there. I have to go to a defensible house if I send her crew and my other guy's crew over there to protect that house that they can't do anything about. We've lost three more and that one. So it's a matter of, well, it's just matter common sense, isn't it? Mark, I just met Mark, so I'm picking on him. Just met him on the road up. So it's just a matter of common sense of that way, if you can help mitigate that, you also have a better chance of sheltering in place, yes, but you're going to get an awful lot of smoke that you're going to get to inhale for a long time. You may get a lot of heat trees that are on fire. And if those start marching up that hill right now, and we see fire coming, coming, coming, that tree's liable to go before it even gets to me, radiant heat will cause these things to torch. And this time of year, take a look around. It's scary. And this is not this is everywhere I go in this county. So coral County all the way to reserve and back there is just so why are they dying? Is that what you asked? There's a ton dying, and it's been a cumulative effect for at least the last two to three years. So last year we didn't get much of anything. This year we haven't had squat. Monsoons were not good. Last year, the year before that, we had a lot of snowfall, which broke a lot of limbs off of pinons and junipers, so those trees are stressed trying to recover. We had a good Juniper harvest last year in Pinon harvest that stresses the trees out so they can recover. We've had no water, so they have no way to recover that way. And the pine beetles, the beetles are coming in, seeing the dead, smelling the live and the live trees don't have enough sap to choke out the beetles. So we're it's just a really bad situation. So as far as this defensible base, somebody asked me about fire wise. Does anybody know what fire wise is? So we do have a county fire wise person. He could not be here today. They can't help you with your property. They won't now you can hire him, and he's reasonable, and he's a good guy. Scott Johnston is his name. He's one guy in the whole county that does it. He doesn't have a crew. But what you can do with Scott, if you get all of your limbs off and get them piled up near the road or something. Give him a call at fire wise in Captain County, and he'll do everything he can to haul it off for you. You're familiar. Have you talked with him? Or you've

Probably it depends on how much you burn and how much Duff, how much tree litter, pine needles and and juniper needles have been sucked into the ground for several inches. It's like briquettes burning something, and it will stay hot for a really long time. What can you do? Douse it with water. We will recall mop up. You douse it with water. You take a shovel or a rake or something and keep stirring it up and dousing it until you get no more steam out of it. You can, 35 you can try and drown it. But if you do not dig it up, it'll it won't, it won't go away. You have to dig it up so the water penetrates, and water gets to do with steam action and cool
