

**VOLUNTEER ATONEMENT REPARATION PLAN** 

Volunteer Reparations is a no-tax Volunteer Reparation Plan, based on Donations. The donations are used to fund Reparation Programs that bring healing and equity to families of Descendants of American Slaves and satisfies Americas need for Atonement and Forgiveness. Volunteer Atonement Reparations provide America with an opportunity to recover its humanity from participation in the transatlantic slave trade and unjust enrichment. It provides the means for people to clear their conscious, answer to a higher power and donate freely, according to their own heart. America was founded on Judeo Christian Principles. The American People are ready to answer to God for the sin of slavery, They are ready to *atone* and give to Reparations. By the Laws of God, the United States owes a debt that must be paid. Save the Soul of America, Volunteer Atonement Reparations is the *solution*.

## **REPARATION PROGRAMS**

The Volunteer Atonement Reparations Plan provides Reparation Programs to rectify the effects of social economic oppression on Descendants of American Slaves and uses donations to provide healing from multigenerational marginalization and inequitable treatment. Reparation Programs offer healing, equity and quality of life to children, youth, adults and families.

## **REPARATION PROGRAM DELIVERY THROUGH LOCAL COMMUNITY CHURCHES**

To guarantee atonement, Save the Soul of America Reparation Programs will be delivered through local community churches across America. Reparation funds will be added to the Churches general operating budget enabling them to expand their outreach to serve the marginalized and oppressed population in their communities. Through Reparation Programs, Church facilities can now offer individual healing, racial equity, economic opportunities, neighborhood improvement, cultural enrichment, housing, education, workforce development, and crime prevention. Our goal is to improve the quality of life for victims affected by the institution of slavery.

## **PROGRAM FUNDING PER CHURCH**

- Church facilities are used as centers for the Reparation Programs
- Monthly funding is provided to each church for Reparation Program delivery
- Includes salaries for reparation staff and a *Program Director*
- Monthly payments for church overhead, operating budget and general funds
- Church retains 10% of all monies received from *income-generating* Programs delivered through their church
