



# PROVISIONAL PLUMBER CERTIFICATION APPLICATION for the JOURNEYMAN

## PROVISIONAL JOURNEYMAN PLUMBER CERTIFICATION IN NEVADA

Nevada Board of Plumbing Examiners (NBOPE) began issuing provisional journeyman plumber certifications for qualifying journeyman and master plumbers on February 1, 2018. The provisional journeyman plumber certification is valid for one (1) year. ***All provisional certifications are issued as a Provisional Journeyman Plumber Certification, regardless of whether journeyman or master plumber credentials are submitted to qualify.*** To obtain certification in the State of Nevada, during or following the one (1) year provisional certification, submit a completed NBOPE Certification Application, including the required fee and a notarized NBOPE Affidavit of Experience, in order to schedule the exam. A Nevada Journeyman Certification will be issued upon passage of the exam.

## QUALIFICATIONS FOR PROVISIONAL JOURNEYMAN PLUMBER CERTIFICATION IN NEVADA

To obtain a provisional journeyman plumber certification, journeymen and master plumbers with a current certification issued by a U.S. state using the Uniform Plumbing Code (UPC) and maintaining standards similar to those required in the State of Nevada, must submit 1) *this completed NBOPE Provisional Certification Application*, 2) *a copy of their current state certificate*, 3) *a passport size photo* and 4) *a processing fee of \$85 to National Inspection Testing and Certification Corporation (NITC) by email to [nbopecerts@nitc.com](mailto:nbopecerts@nitc.com) or by mail to the NITC, 501 Shatto Place, Suite 201, Los Angeles, CA 90020.*

The standards currently required in the State of Nevada include a minimum of four (4) years in a state registered, accredited apprenticeship program or eight thousand (8,000) hours of substantiated experience in the plumbing trade and passage of a fifty (50) question open-book exam and passage of a one hundred (100) question closed-book exam.

NBOPE shall retain final authority on which states qualify under these requirements.
