Committee Reports:

Finance Officer: The finance report was read. A motion was made by Vicki Skipper-Compton to accept the Finance Officers' report subject to audit. The motion was seconded by Kaytlyn Satterwhite, without any discussion motion passed.

Ast. Director: Last month's totals: 13,788 miles, 1,737 hours, and \$900 in donations. YTD: 110,88.8 miles, 13,190.65 hours, \$7,170 in donations. Please everyone report your miles and hours, all Legion business counts. Any fund raising, post business, rides, charity events/fund raising counts towards our miles and hours for the year.

Chaplin: No report.

Sgt at Arms: We have 27 members, and 4 guests present today, and \$31 dollars in the Rider Down Fund. Please save the pop tabs from the tops of your can for me, I donate them to the Ronald McDonald Charity House.

Guests: Stacy, Bobby, & Joe "Crime Scene":

We are here from Post 129 to talk to you guys about our "Casino Night". This year it will be on February 28th. It is our biggest fund-raising night of the year, we partner with Project Vet Relief, an organization that provides resources for the prevention of veteran suicide. They do this by providing resources, outreach, and raising awareness. They are a nonprofit organization so they need our support.

I will leave flyers for the event if you are interested in attending. You can purchase your tickets online or from us directly. We will have gambling tables, Crapps, and roulette set up. We will also have a private VIP room set up for a little extra cost, in the VIP room you do not have to leave your table to get a drink or food so that is the benefit of spending the extra money. This year will be a pirate theme. Regular tickets cost \$50 per person, and the VIP room tickets are \$75 per person. Food will be included in the cost of the ticket, we will also be raffling off baskets and prizes. Thank you for your time.

Kitchen Coordinator:

On November 6th we served chicken tenders and fries: we brought in \$290. It cost \$104.92 for a total profit of \$185 with nine volunteers.

On November 21st we served Salisbury steaks, with mashed potatoes and gravy, and broccoli: we brought in \$606. It cost \$218.75 for a total profit of \$387.25 with seven volunteers.

On November 25th we served tacos: we brought in \$385. It cost \$173.73 for a total profit of \$211.27.

December's meals will be: 4th- chicken tenders with fries, 19th- Ed's Seaside Subs with fries, 23rd - steak or chicken fajitas with yellow rice and beans.
