"... OF ALL PERSONS WE HAD HARMED"

... and became willing to make amends to them all.
—TWELVE STEPS AND TWELVE TRADITIONS, p. 77

One of the key words in the Eighth Step is the word all. I am not free to select a few names for the list and to disregard others. It is a list of all persons I have harmed. I can see immediately that this Step entails forgiveness because if I'm not willing to forgive someone, there is little chance I will place his name on the list. Before I placed the first name on my list, I said a little prayer: "I forgive anyone and everyone who has ever harmed me at any time and under any circumstances." It is well for me to contemplate a small, but very significant, two-letter word every time the Lord's Prayer is said. The word is as. I ask, "Forgive us our trespasses, as we forgive those who trespass against us." In this case, as means, "in the same manner." I am asking to be forgiven in the same manner that I forgive others. As I say this portion of the prayer, if I am harboring hatred or resentment, I am inviting more resentment, when I should be calling on the spirit of forgiveness.

Siouxland Intergroup Meeting Minutes from July 18, 2019

The meeting was opened at 7:00 P.M. with the serenity prayer and introductions by intergroup chairman Tim L; followed by the intergroup statement of purpose and the central office statement of purpose which was read with 8 members present.

Secretaries Report: Secretary Josh C. was unable to attend this month. The Secretaries Report was given by Central Office Manager Mike H by reading the Intergroup Meeting Minutes from the June 20 Intergroup Meeting. A correction to the 'Secretary's Report'. was made with wording changed from 'A motion to accept the Treasurers report....', and a correction was made to the Treasurers Report. That correction changed the wording of 'We have seen an overall income in net income...' and corrected to read 'We have seen an overall decrease in net income...' A correction was made to the District 1 Report was made with wording changed from 'District wrote a \$900 check for the Unity Dinner.' and corrected to read 'District 1 wrote Intergroup a \$900 contribution check from proceeds of the last Unity Dinner.' And corrections were made throughout the report which 'added the last initials to 6 names and 1 first name was capitalized' A motion was made to accept the Secretaries' Report with changes was made by Jerry K. and seconded by Paul T. Motion passed

Treasurers' report: Treasurer Mike W. gave the Treasurers' Report. Compared to 2018, our 2019 Group Contributions and literature sales are down and currently we are at a loss of about \$500. With our Prudent Reserve, Saving and Checking account balances we are still doing ok for now. Hopefully Contributions and Literature Sales will pick up and reduce the deficit. A motion to accept the Treasurers' Report was made by Paul T and seconded by Jerry K. Motion passed.

District One Report: The District is looking into finding a different location to house the Archives. The mileage is was raised from .28 cents to .35 cents. Corrections is in need of someone to take over bring AA meetings to Juvenile Detention on Monday nights.

Functions and committees: Theresa J. who has been chairing the Hotline Committee for the last 2-years is stepping down from that position so we are looking for an AA member to take over that Committee. There is also 1 time slot for the Hotline which is on Sunday from noon to 8pm. Please contact Mike H at the Central Office if you are interested. The upcoming Unity Dinner is Saturday, August 10th. The flyer is out with AA and Al-Anon speakers to be announced. District 1 is hosting the upcoming Labor Day picnic at the Stone Lodge in Stone Park.

Old Business: For the upcoming Intergroup/Central Office Seminar in Mesa, AZ, the event registration, Hotel Reservations and plane ticket have been taken care of and expenses are within the budget.

New Business: Mike H asked a question; "No new meetings will listed in the meeting schedule without registering with Intergroup so we have accurate and current for each meeting in the area. The reason for this request is in reference to the new Meeting Guide App that has been approved to use by GSO and lists meetings all over North America not just the USA. The information listed on the app for the Sioux City area is derived from information provided by Area 24. If that information is not current, people using the app that are coming to Sioux City may show up for a meeting which may have moved or no longer meets. There will be more discussion on this at a later date. Mike H wants to have a meeting with the Intergroup Secretary and District 1 Secretary and Newsletter Chairs to come up with a standardized format for Intergroup/District information put on the website.

Announcements: Remember to spread the word about the upcoming Area Challenge about \$8.06 on 8/6 (Aug 6) to help GSO not have a deficit in there budget. Also remember about the Unity Dinner and Labor Day Picnic.

A motion to close the meeting was made by Paul T. and seconded by Mike H. The meeting closed at 8:06 P.M. with the Lord's Prayer.
