



Then their eyes were opened, and they recognized him; and he vanished from their sight. They said to each other, “Were not our hearts burning within us while he was talking to us on the road, while he was opening the scriptures to us?” --Luke 24:31-32

The above passage is from the end of the “road to Emmaus” account in which some of the disciples encounter the risen Jesus while walking to the village of Emmaus. It is here at the end of the story, in retrospect, that they recognize the significance of what they had experienced along the road. Ideally, we would regularly take stock of our experiences as we go through life. Realistically, whether because of factors like time constraints or not yet recognizing an event as significant in the moment because the consequences are not yet known, it is much more likely that our eyes will be opened to the impact of our experiences at a later point.

For several weeks, I have been thinking about what I have learned, had reaffirmed or how I have been impacted by these 7 years at Gray Memorial United Methodist Church. Here are some of them:

- ✂ Gray Memorial is a resilient church. Fire (in the old boiler), flood (failed sprinkler), plague (COVID), theft, two people who weren't what they claimed and the loss of beloved members of this community have not deterred this congregation. To be sure these events have been challenges in a variety of ways and have left a lasting mark on us, yet they have not ended the witness nor extinguished the spirit of Gray Memorial.
- ✂ When the congregation puts its collective mind to a situation, Gray Memorial is both resourceful and generous. Many have been the recipients of meals, prayer shawls, cards, phone calls, visits and more during times of need. Many have given selflessly of their talents (music, carpentry, technology, finance & worship to name a few), time (many giving hundreds of hours) and treasure in support of our ministries. The Pen Pal letters have been impactful beyond anything I imagined. And despite what many thought couldn't or shouldn't be done, the Growing in Faith capital campaign—with foresight of several Trustees—has multiplied and stewarded the gifts for the campaign to accomplish a volume and a quality of needed projects far beyond anything I have experienced.
- ✂ We have been taught, “necessity is the mother of invention.” Without the pandemic, I would not have learned so much about using technology in ministry nor would the congregation be in using technology the way we now are for worship, studies, meetings, building maintenance and more.
- ✂ Living in Aroostook County has brought new language (“dooryard,” for example) and many places I had never experienced before, from Ft. Kent to Hodgdon, from DeBoullie to Mars Hill to Scopan, from Nordic Heritage Center to 10th Mountain. Beautiful? Ayuh!
- ✂ People are people wherever they are...and God's children, too. Life's details vary, but the core of our humanity is fairly constant. There are hopes, dreams, goals, fears, joys, sorrows, heartaches, triumphs, a desire to love and be loved, strengths and shortcomings. There are times when God reigns in our lives and times we do not live after the example of Christ.
- ✂ God is good all the time and all the time God is good—even when it doesn't feel like it. I continue to believe that God is and always at work. The question is whether we and the church will be part of the Holy Spirit's activity.
- ✂ When you think you have seen it all, wait awhile (like with the weather) and pay attention. Most of the items in point one above were new church experiences for me. Who saw the pandemic coming? For me, the Gray Memorial sanctuary continues to be the most beautiful of any I have attended or served. I enjoy sitting in the sanctuary at various times of the day with the light streaming through the multicolored sections of glass.

When you look over the last several years, what have you learned? How have you witnessed God at work?

Reminder from Rev. Tim -

Rev. Tim's is available for appointments Tuesday - Sunday with Monday being his usual day off. His cell phone number is (207) 551-7924. Depending on the situation, he can arrange for the particular means for the meeting as necessary.

On Rev. Tim's day off (usually Monday), on a Saturday, or in an emergency (for example, a death, hospitalization or family crisis) the best way to reach him is by first calling the parsonage, 207-492-0371. Someone is at the parsonage most of the time. For the most part, he does not often check phone or email messages on a day off or during family time.

When Rev. Tim is traveling and on most other occasions, the best way to reach him is on the cell phone, 207-551-7924. You can also call the church office at 207-498-2103. Ordinarily, his goal is to respond within 24 hours. It may take additional time to return your call when he is traveling or when a day off is involved.

If you have any questions or need more information about reaching Rev. Tim when needed, please contact him.

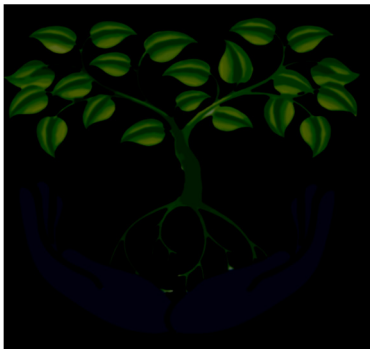

WORSHIP:

Meeting on Friday, April 1st. Members present: Bobbi Pelletier (chair), Claire Hodgkins, Richard Clark, Neal Genz, Beth Alden, Gwen Ellinwood, Diane Fitzpatrick, Margaret Cyr, Rev. Tim Wilcox
The meeting was called to order at 9:30am by Bobbi Pelletier, chair.

Devotions were offered by Diane, a reading called "Two Horses", on how God places people in our lives to help and guide us. The minutes from our March meeting were accepted.

Old Business:

- African palms have arrived and will be given to people entering worship on Palm Sunday, March 10. We will be able to write the name of a person in need of prayer on the palm and then place it on a small table in the front of the church, or we may choose to take it home. The palm arrangement for the altar and the palm fronds have also been ordered. The fronds will be passed out as people leave the sanctuary following the service.
- Holy Week services have been scheduled for 12:00 on April 11 – 15. We are not sure at this time if the services will be provided on line (*they were*). We do know that the Cluster Maundy Thursday service will be on line and Rev. Tim will speak with Alaina about our Good Friday service also being offered on line in addition to in-person.
- Refreshments for the Holy Week services will be provided for on Monday by Holy Rosary and on Friday by the Caribou United Baptist Church. Bobbi has not heard from the other churches. We will be responsible for set up, serving, and cleanup every day. If we need to provide refreshments on Tuesday – Thursday, we will provide sandwiches and sweets.
- The Good Friday evening service will be held at 7:00 p.m. Richard offered to serve as liturgist and Bobbi asked that we have ushers as well. (*Margaret has volunteered to play the organ.*) Bobbi will strip the altar of flowers and paraments that morning before the noon service.
- Easter flowers will be arranged at 1:00 on Saturday, April 16.
- Neal reported that we have permission to use the Caribou Country Club parking lot for our sunrise service on Easter morning. (*We changed location due to snow; new location was the Caribou Rehab & Nursing Center.*)
- May 1 will be Native American Ministry Sunday. Special offering envelopes and pew cards will be made available.
- May 8 is Mother's Day. Bobbi will order devotional booklets to be given to all women attending the service.
- June 5 will be Graduation Sunday. Alden Wilcox is our only graduate to be honored. Beth offered to prepare a gift of a framed picture of our church to present to Alden from our committee. The scholarship process is in the hands of the trustees.
- June 12 is Peace with Justice Sunday. Special offering envelopes and pew cards will be used. There will also be a reception for the Wilcox family that afternoon.
- June 19 is Father's Day and St. John's Sunday. Bobbi will order devotional booklets to be given to the men on that day.
- June 19 will be Rev. Tim's last Sunday with us before he and his family move to New Hampshire.
- In light of recent security issues, it was mentioned that the front door of the church will be locked 15 minutes after the service ends each Sunday and folks remaining longer will be asked to use the side door by the office. Rev. Tim will announce this policy from the pulpit.

New Business:

- Rev. Tim will be away on May 1, so Communion will be offered on May 8. People attending will be given a choice on how they wish to receive the elements, either with the pre-packaged ones we have been using or going forward to receive elements from Rev. Tim.
- Coffee fellowship will resume on the last Sunday of April with our committee providing refreshments. It was decided to provide light refreshments! (Bobbi will contact other committees in order to create a schedule for the rest of the year.) (*It was later decided to postpone starting offering Coffee Fellowship until May 15th.*)
- Beginning on July 3, people will be asked to resume wearing our name tags as we will be welcoming Pastor Rego. Rev. Tim mentioned that we might think about whether we wish to have Pastor Rego

preach on his first Sunday or have a guest speaker so that he can simply listen and enjoy the service.
(Update – Pastor Rich does plan to lead worship on July 3rd)

- Rev. Tim addressed the progress that has been made on our new sound booth. He has met with Will and Alaina and they have it ready to use this coming Sunday, April 3. He also mentioned that the tech team needs volunteers to help run Sunday services. Bobbi mentioned that new headphones will be purchased to make it easier for hearing- impaired folks to hear the service better. Bobbi suggested that we should have a special dedication of the new sound system once it is up and running well.
- Rev. Tim mentioned that Alaina has offered to put all the various pieces of the Maundy Thursday Cluster pieces together so that it can be offered on line.
- Rev. Tim mentioned that Pastor Sue Brown will retire from the Mars Hill church at the end of June. Coverage for the Washburn church will be provided by Pastor Ellen Cleaves through the summer but is unknown after that.

Our next meeting will be held on Friday, May 6, at 9:30 at the church.
Gwen Ellinwood volunteered to offer devotions.
