The New Year is upon us! Even as I look back at the lessons, challenges, and blessings that came with 2025, I have a growing sense of anticipation for what's to come in 2026. Gratitude is the defining word for the present moment, whether reviewing the past or looking forward, since God is ever faithful and present to lead the way, through it all. Proverbs 3:5–6 states, “Trust in the Lord with all your heart and lean not on your own understanding; in all your ways submit to him, and he will make your paths straight.” As 2026 begins, we'll be exploring joy through simplicity and generosity through a four-week study based on Adam Hamilton's teachings in the book *Enough*, which will meet in the parsonage on Wednesdays at 3pm, beginning January 7<sup>th</sup>. As one year draws to a close and the next one begins, I invite you to pray the Wesleyan Covenant prayer with me, which has been a Methodist practice at the New Year since the founding days of the movement.

### Wesley's Covenant Prayer

“I am no longer my own, but thine.  
 Put me to what thou wilt, rank me with whom thou wilt.  
 Put me to doing, put me to suffering.  
 Let me be employed by thee or laid aside for thee,  
 exalted for thee or brought low for thee.  
 Let me be full, let me be empty.  
 Let me have all things, let me have nothing.  
 I freely and heartily yield all things  
 to thy pleasure and disposal.  
 And now, O glorious and blessed God,  
 Father, Son, and Holy Spirit,  
 thou art mine, and I am thine. So be it.  
 And the covenant which I have made on earth,  
 let it be ratified in heaven. Amen.”

Wherever your New Year's reflections bring you, whether reviewing what has passed, or looking forward to the future, remember this for your present: you are blessed, highly favored, and deeply loved, in Christ.

***Is your household or someone you know experiencing food insecurity? The Caribou Ecumenical Food Pantry serves the communities of Caribou, Connor, Woodland, Wade, Washburn and Perham and will provide food to those households that meet income guidelines. The Pantry, located at 31 Herschel Street in Caribou, is open on Tuesday and Thursday mornings from 8am to 11am. Please call 493-4860 between those hours and the pantry volunteers will help provide you with food boxes (available every 4 weeks or as needed).***



The Worship Committee has resumed their Mission Project to provide supplies to the schools. These are the items needed: shampoo, soap, deodorants, toothpaste, notebooks, bookbags, folders, colored pencils. They also have a “snack closet” the kids come to quite often for items like gummies, cheez nips, trail mix; any single serve items, water, juice boxes. Marked boxes are in the library. Please consider donating to this project! Thank you!

Gray Memorial UMC has an account at the Bennett Drive Redemption Center. When you bring your bottles/cans to the center, you may designate the proceeds to go the church’s account! If you are not comfortable bringing them yourselves, you may bring them to the church and we will take them to the Redemption Center.  
*We did not receive any donations in November or December, so proceeds remain at \$1,337.80! Please remember that these donations help offset our operating budget expenses!*

- By Vanco Mobile, an app provided by VANCO. You can download on an Apple or android phone. This method supports both recurring and one-time gifts.

All VANCO methods include a nominal service fee for the church. Many people choose the options provided by VANCO for convenience and, for the electronic options, to ensure their gifts are always regularly given. Because of regular giving, research shows churches receive more funds overall using these methods.

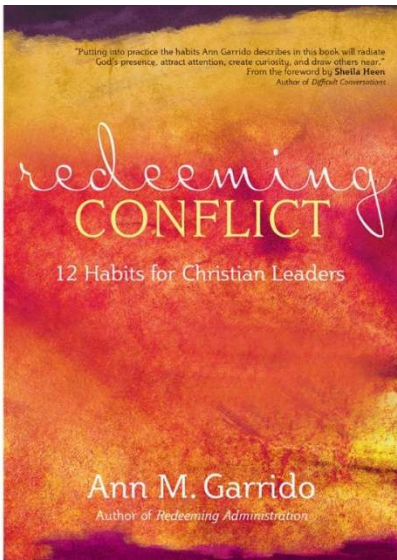

Announcement from our Staff Parish Relations Committee (SPRC):

Gray Memorial has an immediate opening for a Financial Secretary. Shirley Bowman has expressed her desire to step down from this position and move on to other plans. Shirley has done a wonderful job over the last three plus years as well as during a previous tenure. She will be greatly missed in this position.

The Financial Secretary position oversees the tracking and reporting of financial gifts to Gray Memorial. It requires weekly deposit reports, a monthly report to the Church Council, two reports annually to donors, and tracking the results of the annual stewardship campaign, all using a computerized software program. Training assistance would be provided. The position also requires a general knowledge of bookkeeping, a detail-oriented work standard as well as an ability to maintain very strict privacy about individual donors and their accounts. The Financial Secretary is expected to attend the monthly Church Council meetings to address any issues brought up relative to the monthly reports.

If you, or anyone you know, might be interested in this position a formal job description and/or a job application can be requested from the church office or from any SPRC member (Melonie Carlson, Cheryl Martin, Kathy Panaro, Dave Belyea, Mary Lou Brown, or Debbie Barnes).

When you have a chance, please express your thanks to Shirley for the great job she has done for our church and wish her many blessings in her future.

**Church Council Report  
December 18, 2025**

Members Present: Roy Alden (chair), Pastor Ben Daggett, Diane Fitzpatrick, Debbie Barnes, David DeMerchant, Mary Lou Brown

Pastor Ben opened the meeting by playing his guitar and having us sing together, “Seek Ye First”.



**Open Discussion Question:** Roy asked us to reflect on this past year at Gray Memorial and to highlight the celebrations we have experienced. All agreed that the arrival of Pastor Ben has been wonderful! We look forward to his ministry here with us! The “pray ground” for the young children is working well and has been beneficial for the children. We rejoice in the help we were able to provide for Pastor Rich and Karen in their move. Hearing the organ being played is a real joy! Pastor Ben expressed his thanks for all the support he has had in preparing to go before The Board of Ordained Ministry. His acceptance as a candidate for ordination is a result of hard work by him and many prayers offered on his behalf.

**Financial Statements:** Debbie Barnes presented the financial reports for the month of November. We began the month with a \$5,814.69 deficit in the operating balance. Debbie reviewed the deposits of regular and special funds that we have received. We are eight months behind in paying our Mission Shares. Discussion was held on what we can do to catch up. Questions were raised as to why our church has to pay so much in Mission Shares. Roy suggested that we meet with D.S. Rick McKinley for an explanation. Pastor Ben will research this and report back. Dave reported that the Trustees will request the use of interest money from the Permanent Fund to pay the Mission Shares. If there is not enough money to cover what we owe, then perhaps the rest could be taken from the Trustee bank account. The end of November checkbook balance shows a deficit of \$4,639.52 in the operating budget.

### **Committee Reports:**

- **Trustees:** \$50,000.00 will be needed to get a solar heating program started. A special fund should be established to cover the cost of the regular tuning of the pianos and organ. The railing on the staircase outside the church office needs to be brought up to code. A plowing contract for the 2025 -2026 season is estimated to be \$4,470.00 and will be done by Jennifer Michaud. The parking lot will be paved at the end of the season. The video replacement equipment is still being worked on. Repairs need to be made on the folding doors in the fellowship room and on the new front door. It is suggested that all church committee meetings be held on one day in order to conserve on heat. Pastor Ben is willing to have some committees meet in the parsonage. It was suggested that Dave DeMerchant, Jud Drake, and Bobbi Pelletier meet with Pastor Ben to work out a meeting schedule. In the meantime, folks using the church will be encouraged to keep certain doors closed, lights turned off after meetings, heat turned down after meetings are held, etc. in order to help with expenses.
- **NOW Committee:** Pastor Ben reported on Melonie’s behalf that she and Elise from the Children’s Museum have met and discussed ways in which our church can support the museum and its programs. The January 7<sup>th</sup> meeting of the NOW Committee will be held at the museum so that members may get to see all that the museum has to offer. An invitation has been extended for others to join them! Denise Hamlin was overjoyed with our Angel Tree contributions and extends her thanks to our congregation.
- **Stewardship Campaign:** Plans are in the works to begin in early January. Pastor Ben and Ellen Cleaves will be leading a study on Adam Hamilton’s book, Enough. Several books for use in the study have been donated. This book will be used as a guide for the financial campaign. Roy suggested that those who will be involved in the study could reach out to other members of the congregation with knowledge they have acquired through this study.
- **SPRC:** Pastor Ben extended sincere thanks to Debbie Barnes for her leadership of the committee for the past six and one-half years. Her leadership has been deeply appreciated!
- **UMM:** On behalf of Neal Genz, Roy expressed thanks for the generous support given by our congregation to the Tree of Lights project. It was very successful! Neal has also set the date of February 17<sup>th</sup> for the UMM Shrove Tuesday Pancake Supper.

The tentative date for the next meeting is set for January 22<sup>nd</sup> at 1:00pm.

❖ Children's Moment

- Cheryl also had a sign-up sheet for those who would like to help Pastor Ben with the Children's Moment. This can be assisting him or doing a lesson alone.
- Pastor Ben shared a variety of resources that provided activities/lessons for this special time with children and other members shared resources/ideas as well.

❖ Visitors

- A new young family attended last Sunday and discussion was held about the importance of connecting with visitors, making them feel welcome, and making sure they receive a visitor's bag.

❖ Stewardship Program

- Pastor Ben asked for input on the upcoming Stewardship program. He shared the book *Enough* by Adam Hamilton which will be offered as a book study. It focuses on generosity and stewardship while offering a practical approach to financial wisdom.
- The committee brainstormed ways to better integrate the Stewardship drive. These ranged from using a holistic approach, making the drive more engaging/fun, not just focusing on the financial portion of stewardship, sharing ways in which members of the congregation are good stewards, etc. Many good ideas were shared and now the next step will be deciding how to implement them.

❖ Handbells

- Alaina shared that the children have Christmas music prepared and will be playing during the evening service on the 24th or Sunday the 28th.

The meeting was closed with a prayer from Melonie.

Our next meeting will be held on January 14th at 9:30.
