

**RESOLUTION 20250508-1**  
**AN ORDER DECLARING THE RESULTS OF**  
**THE CITY OF TIMPSON GENERAL ELECTION AND SPECIAL ELECTION**  
**CONDUCTED ON MAY 3, 2025**

**WHEREAS**, the City Council of the City of Timpson resolved and ordered a General Election in the City of Timpson Texas for the purpose of electing the following City officials to the Timpson City Council and resolved and ordered a Special Election for the purpose of voting for the legal sale of all alcoholic beverages including mixed drinks (PROPOSITION 1):

- Council position, two (2) year term
- Council position, two (2) year term
- Council Position, two (2) year term

**Proposition 1: FOR/AGAINST The legal sale of all alcoholic beverages, including mixed drinks.**

**WHEREAS**, there came on to be considered the returns of a General Election held on the 3rd day of May for the purpose of electing three (3) Council members to the Timpson City Council and a Special Election held on May 3<sup>rd</sup>, 2025 Proposition 1: To legalize the sale of all alcoholic beverages including mixed drinks.

That PROPOSITION 1 – To legalize the sale of all alcoholic beverages, including mixed drinks PASSED with 107 votes FOR legalization.


**SECTION 1.** That is further found and determined that the results of the Election as canvassed and tabulated reflect the expressed desires of those persons voting at said election
