#### From the National Grange Website:

Food security is multi-dimensional. Availability, access, affordability, use and stability of food and clean water are each a piece of the puzzle. In the United States, about one out of every seven people are food insecure according to feeding America.

Most people assume that in rural communities where most food is grown, food is abundant, accessible, affordable, and the supply is stable, yet rural Americans are more likely to face food scarcity, live in food deserts, encounter challenges to clean drinking water, and have economic challenges to accessing food with adequate nutrition.

Granges, since our earliest days, have tackled the issue of food insecurity from every angle. From the fight against railroad monopolies charging farmers exorbitant rates to ship food and threatening the food supply chain for millions, to common modern Grange events and projects such as low-cost community dinners, free food pantries, and community gardens, Granges are no stranger to finding innovative ways to ensure members, their neighbors, and those around the nation and world can access food. Each of these modern projects fall under the first ribbon of the Project Sustenance banner.

In addition, many pieces of National Grange policy align with this portion of Project Sustenance, such as advocacy for the Farm Bill and funding for infrastructure projects to ensure clean water for rural communities.

With Spring and Summer just around the corner (I hope), comes working in the yard, gardens, and fields. Using lawnmowers, garden tractors, leaf blowers, weed trimmers to large tractors and other machinerv.

Are you prepared to protect your hearing?

Several years ago we had available brochures and posters called "Your Noisy World Could Get Silent." We no longer have the posters available, however I do have a hand full of the brochures.

I thought this month I would go over some of the information regarding deci-

bels and just how various items can hurt our hearing if not protected against it.

The brochure starts out saying that Noise is more than a nuisance and I really do believe sometimes it truly is. Our ears are constantly being assaulted by the racket of the modern world. I live in town and I have to put up with the noise of the loud vehicles, motorcycles and in my neighborhood the trains going by, especially during the summer when the windows are open. It's not something that you know is going to happen so you could protect your hearing.

Normal everyday sounds are loud enough to damage your hearing if you hear it often enough. Such as these items:

Such as these items.	
Washer 40 dB	power tools 85 dB
Dryer 55 dB	Vacuum 62-85 dB
Blow Dryer 59-80 dB	Dishwasher 54-85 dB
Stereo, up to 120 dB	Heavy traffic 80 dB
Radio, up to 120 dB	Sewing machine 64-74 dB
TV, up to 120 dB	Electric Shaver 75 dB
Lawn Mower 87-95 d	B Food Disposal 67-94 dB
Chain saw 100 dB	Refrigerator 40 dB
Passenger car 70 dB	Circular Saw 103 dB
Window Air Conditio	ner 80 dB

The loudness of sound is measured in decibels (dB). The human ear can typically hear sounds between 0 dB and 120-140 dB.

#### **Examples of decibel levels:**

0 dB: The guietest sound a healthy human • ear can hear

- 20 dB: Whispering at 5 feet •
- 40 dB: A quiet library •
- 60 dB: Ordinary spoken conversation
- 85 dB: A food blender
- 110 dB: A live gig or concert
- 120 dB: Thunder
- **130 dB**: An aeroplane taking off 100m away

140 dB: Fireworks, gun shots, custom car stereos (at full volume)

#### Effects of loud noises:

Extended exposure to sounds above 85 dB can • cause hearing damage.

Exposure to 70 decibels over a period of 24 hours is considered a level that can prevent measurable hearing loss over a lifetime.

There are so many ways to protect your hearing from earplugs to earmuffs to just staying away from those loud noises that you can and how about turning the volume down on the TV and radios.



Losing your hearing is no fun for anyone. I know a lot of people that struggle with hard of hearing, some with hearing aids some that

don't. Even those with hearing aids have problems at times if they are in a room that has a lot of noise or a lot of people talking at once.

The Upton Grange in Massachusetts recently posted a very informative article on Susan B. Anthony. The text from the article is below. I hope this helps you build a program for Grange Month. The Grange was the fore-runner including women as a full member of the organization from its inception. We can thank Caroline Hall for her insistence that the woman's role on the farm was important to the success of the farm/community success, and the Grange should recognize that with full membership.

#### Susan B. Anthony 1820-1906

Ms. Anthony was born in Adams, Massachusetts. Ms. Anthony is noted for being an American reformer and was one of the greatest leaders in the advancement of women. She founded the first state Women's Temperance Society and was one of the founders of the National Woman Suffrage Association. She was very active in the anti-slavery movement. In 1869 she founded the Woman's Suffrage Association along with Elizabeth Cady Stanton. She was arrested, tried and fined in 1872 for attempting to vote under the Fifteenth Amendment in New York. Susan Anthony looked to the Grange for support in her cause, since women in the Grange were equal to men in all the roles within the organization. Many Grange women supported her cause. On November 10, 1895 Ms. Anthony wrote a letter to The National Grange and delegates. The letter is as follows: My dear Friends: --I see by the newspapers that you are to meet in national convention in the good city of Worcester on November 13th, and while feeling grateful for the many resolutions you have passed in favor of woman's enfranchisement during the last several years, and also for your practical recognition of "equal rights for all" by the election of women to the various offices of your association, I still want to remind you that now is the time for you to give a stronger expression in favor of woman suffrage than ever before. We have

obtained school suffrage from the legislatures of twenty-three states, municipal suffrage from one, full suffrage by constitutional provisions in three, and there are today pending woman suffrage amendments to the state constitutions of five different states, viz: New York, Oregon, Idaho, Nevada and California. In California, the amendment is to be voted upon at the election of 1896, and you surely will agree with me that the hope of carrying it depends very largely upon the constituencies of the Patrons of Husbandry and of the Grange in that state. It therefore becomes the duty of your National Convention to send out recommendations, if not instructions, to your local branches in California to do all in their power to carry the amendment at the polls. The suffrage Amendment Committee of California with Mrs. Sarah B. Cooper and Mrs. Ellen Clark Sargent at its head, is now organizing township societies throughout the rural districts and ward societies in the cities, for the purpose of forwarding the educational work on this question and a word of encouragement from your national body will do a great deal to stimulate the members of your branches in that state to unite with and help on the work of this campaign committee. In the hope that you will throw the weight of your influence on the side of the establishment of a genuine "republican form of government" in every state in the Union, and wishing you the best of success in your convention, I am, Very sincerely yours, Susan B Anthony The National Grange continued to support the women's suffrage movement over the years, and even had a Committee on Woman's Suffrage. At the fiftieth annual session of the National Grange, this Committee made the following recommendations: 1. That the National Grange reaffirm its unqualified endorsement of woman's suffrage and urge all State Granges to take similar action. 2. That the National Grange endorse and support the movement to secure equal suffrage by amendment of the Federal Constitution. Susan B. Anthony's last public appearance was at the National Grange Convention in 1903. Once again, the women of the Grange help form our country.

Hopefully Spring is right around the corner! National Grange has given some do's and don't on creating your Community Service Books.

The Community Service Team, share the following suggestions when putting together your Community Service book. They need to reminds us that these are just suggestions to make the book flow better and make it easier on the people putting it together. State Granges may have different ideas or suggestions. More pages or larger books are not always better. Good organization is important. **This is not a history book of everything your Grange did in a year, just the Community Service projects.** It is important that the name of your Grange is on the front of the book.

#### Suggested DO's

• Include a short write up about your Grange and Community. (1 page max)

• Limit pages to no more than 4 (front and back) for larger projects and 2 (front and back) for smaller projects

• Include 2 or 3 photos that demonstrate members (& nonmembers if applicable) participation and items collected. If it is a cleanup type project before and after photos.

• 1 or 2 Thank You cards/letters for an event.

• An overall summary sheet listing continuing projects, new projects, larger and smaller projects and list of donations. Then utilize this format for the organization of the community service book.

• Include any newspaper article or flyer about the event. When holding a fundraiser dinner/event it is important to include where the monies were donated.

#### Suggested DON'Ts

• Don't include things like State session programs in this book, officer and member rosters and meeting minutes.

• Don't include members or family obituaries because the family used your hall after the funeral.

• Don't include every thank you note/letter you get from a project. One is enough, not all 30 from a class you donated dictionaries to.

• Mowing the grass at the Grange Hall – maintenance not community service.

Our Granges are doing many exciting projects throughout their communities I would love to share something your Grange is or has done this year. Just let me know and I'll put it in the Michigan Grange News. Michigan's Community Service reports should include,

#### The Notebook Reports:

- The summary report should be placed at the beginning of the Notebook. This form is required!
- Material should be organized. Suggested ways to submit the Notebook is to have the projects grouped together by the size of the project, chronologically or have your Notebook read like a book. Easy to read and follow activities. This is your opportunity to tell the story of your Grange in a neat and concise manner.
- Please do not send more than one Notebook. Notebooks cannot be larger than a 2-inch binder! More isn't always better!
- Videotapes and computer discs cannot be used in place of a report for judging.

#### **Projects:**

- Describe the new and old project(s) that will answer the Who? What? Where? When? Why? And How?
- Why did you choose this project? Did it benefit the community? Did you overcome obstacles? Did you record what you would do differently?
- Would you recommend this type of project to other Granges?
- Include the details of the work. Were there special committees? Did it take cooperation of other groups? How many Grangers and non-Grangers were involved? What did you accomplish? Describe your successes.
- Include support materials used such as publicity, pictures, news articles & letters.
- Keep the report concise. Include only material that directly impacts the projects you are explaining.
- On the Project List pages: List the projects, the approximate number of hours spent on each project. List the number of Grangers and non-Grangers who assisted with the

project. If more space is needed use additional pages.
