Agenda Item 1 –CONSIDER AND TAKE ACTION ON APPROVING TEMPORARILY CLOSING THE FRANKLIN COUNTY COURTHOUSE DUE TO EMERGENCY STRUCTURAL DAMAGE TO BELL TOWER – COUNTY JUDGE – Bob Stinson gave an update on the damage and repairs thus far. The structural engineer that he contacted, Dave Gillespie, has assessed the situation. The immediate threat of the counterweight falling further has been resolved. New projected date for reopening the courthouse is Monday, June 5, 2023, if all goes according to plan. Estimated cost of repairs is approximately \$60,000.00 per the first report by the insurance adjuster. Due to possible liability issues, the building will remain closed until repairs are complete and fire suppression system is functioning properly. Most offices will remain closed until June 5th. The District Clerk will relocate to the Law Enforcement Center, and the County Clerk will relocate to the Annex East building. Future possibilities regarding clock and bell tower were discussed. No official vote or action taken.
