Wood County Electric Cooperative (WCEC) reported they are 100% operational. No one from SWEPCO was in attendance. There was discussion of CSSUD generator issues and Kevin Spence asked WCEC how they prioritize critical customers and zones to get power restored to faster. They stated in this instance, there was just no way to isolate areas because of the amount of damage and county-wide outage. Tim Dial stated more water, ice, and MREs arrived at the HS last night, and he also has more fuel coming. Ice, water, and MREs will continue for the rest of the week. He said he is hanging on to all generators until they know everything is good. Nathan Carroll (TDEM) said a base camp for the medical and military personnel has been set up at the school. No official action taken.
