Judge Lee called the meeting to order at 9:00 A.M.

Commissioner Smith offered the prayer.

## Items discussed:

- 1. Jan Switzer and Jodi Jones addressed the Court regarding the PAWS Animal Shelter. They are currently under contract to purchase the vet clinic building located on the I-30 South service road (old Dr. Reed office). They want to sit on the other site for at least a year before making a decision on what to do with it. It will be utilized for storage and other needs. Hope to be operational in 3-6 months.
- 2. Big ticket items priority/wish lists presented:
  - Pct. 4: backhoe, dump truck, motor grader, side wing tractor
  - Pct. 3: 2 dump trucks, haul trailer-to benefit all precincts
  - Pct. 2: motor grader, dump truck, additional ¾ or 1-ton truck
  - Pct. 1: bucket truck, skid steer, Jarraff tree trimmer-to benefit all precincts and in lieu of bucket truck
  - Sheriff: 2 cars or digiTICKET software
  - EA: Vista software for election records management and retention
- 3. Marla would like to set total cap around 1.5 million. She will type up the list for the Court to review and prioritize for year 1.
- 4. Sheriff stated software upgrade for auditor/treasurer can come out of inmate housing.

- 5. Marla wants to get the generator for Annex East before the end of the year and it can be paid for out of fund balance.
- 6. Next budget workshop set for 07/28/2023 at 9:00 AM. Put purchase of Annex East generator on next agenda.
- 7. Landon has expressed an interest in the current Justice of the Peace office space once they get moved to the new building.
- 8. Sheriff received a quote of approximately \$20k per washer for the jail.
- 9. Status of clock/bell tower still waiting on written reports.

<u>Adjourn</u> - Commissioner Emerson made a motion to adjourn the meeting and Commissioner Cooper seconded the motion. Motion carried 4-0. Meeting adjourned at 10:12 A.M.
