Judge Lee reported after review of the expenses presented, it is determined that the level of the proposed 2023 tax rates needed to fund the FY 2024 budget are as follows:

- General Fund .25960
- RBS .01538
- Lateral Road .09451
- I&S .01387
- Total Proposed 2023 Tax Rate for FY 2024 budget is .38336

Commissioner Cooper made a motion to approve the proposed 2023 tax rates to fund the FY 2024 budget. Commissioner Smith seconded the motion. Individual votes were taken as follows:
