## Franklin County Commissioners Court Commissioner Court Minutes Workshop Session August 1, 2024

The Franklin County Commissioners Court met in a Workshop Session on August 1, 2024, at 1:00 PM in the Commissioners' Courtroom at the Franklin County Courthouse located at 200 North Kaufman Street, Mount Vernon, Texas.

Judge Lee called the meeting to order at 1:00 PM. Commissioner Smith offered prayer. The Pledge of Allegiance to the American flag was recited.

## Items discussed:

- 1. City Manager Craig Lindholm introduced the new Fire Chief, Blake Sheffield.
- 2. Judge Lee asked Yesi Castro if voting could be moved from the HUB side to the other unused side of the building.
- 3. Lisa Lawrence reminded everyone tomorrow is Watermelon Day at the library.
- 4. Budget -
  - Health insurance increased emergency room copay. Leave the rest the same for now and explore alternative options in the future;
  - Retirement increase county/employer match from 2.0 to 2.25, and increase retirees to 30% of CPI. Elective rate is currently 12% and will increase to 12.63%. Instead of 99% funded, we will be 92% funded. There are currently 41 active retirees and there hasn't been an increase since 2007;
  - NNR rate is .35228 and valuations are \$1.982B. That brings in \$4,612,683 to the general plus \$460K for Over 65 and Disabled for a total of \$5,072,000. With a 2% delinquent rate estimate, that leaves \$4,971.000.
  - Debt Services payment for next year is \$370,000;
  - Lateral Road & Bridge valuations are \$1.977B which brings in \$1,719,176 to County Wide Road & Bridge plus \$165,000 Over 65 and Disabled totaling \$1.884M;
  - Road & Bridge Special is \$333K with a net of \$326K;
  - Budget increases:
    - A. Health/Dental Life Insurance.
    - B. Portion of 8<sup>th</sup> and 62<sup>nd</sup> Judicial Court/DA costs.

- C. Utilities.
- D. Salaries elected officials and 7% COLA for employees.
- E. PAWS \$10K.
- F. CDL training \$10K (\$5K reduction).
- G. Appraisal District budget.
- H. Retirement.
- Sheriff's Office deputy overtime. Cannot pay overtime out of SB22 funds.
- J. Volunteer Fire Departments increased to \$20K for Purley, South Franklin, and North Franklin. Winnsboro remains at \$2K.
- Requests/items not included:
  - A. Maintenance pull-along sprayer;
  - B. Airport Community room roof and culvert repair;
  - C. Full-time assistant for County Judge \$54K;
  - D. One part-time to full-time at the library \$29K;
  - E. Part-time for Extension Agent \$8K:
  - F. 3 full-time deputies for S.O. paid from Inmate Housing \$254K;
  - G. Remodel existing JP's office on bottom floor for County Attorney and staff;
  - H. New windows for County Judge's office:
  - I. Possible remodel at S.O. when tax office moves out;
  - J. Installation of courthouse generator;
  - K. Awnings for the exterior doors on the bottom floor.
- Future needs/items to consider: Airport bathrooms, dugout awnings, and potential lease of sports complex.
- Sheriff Fund 3 new deputy positions out of Inmate Housing. Would like to see the county eventually cover these if funds allow.
- Total revenue is approximately \$7.4M. Total expenses with addition of employee raises, elected official salary increases, increases to retirement, and a full-time assistant for the County Judge are \$7.6M, leaving a deficit of \$149K.
- Discussed whether or not to increase proposed tax rate. Leave as is for now.
- 5. Meet Monday, August 5<sup>th</sup>, to set proposed tax rate.

<u>Adjourn</u> - Commissioner Smith made a motion to adjourn the meeting and Commissioner Emerson seconded the motion. Motion carried 4-0. Meeting adjourned at 2:31 PM.
