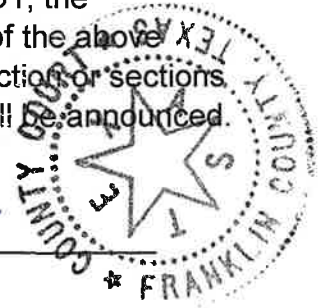
12. Motion to Adjourn
