The city is continuing improvements on the facilities. They have currently taken in approximately 60 dogs and 15 cats so far. The goal is to have animals come in with quality of care. They don't want to take in more animals than the staff can handle. Jan Switzer informed everyone that Dr. Cranmore's clinic has donated all of their dog and cat supplies to support the shelter. Ruth Greene inquired about animals being turned away and also volunteer opportunities. Dr. Glaess explained they are not fully open yet as they are waiting on all improvements to be completed, and Jennifer with the City of Mt. Vernon is working on the volunteer forms.
